Global forest goal 1 and associated targets¹

Reverse the loss of forest cover worldwide through sustainable forest management, including protection, restoration, afforestation and reforestation, and increase efforts to prevent forest degradation and contribute to the global effort of addressing climate change

Description of actions:

Ministerial Decision on Resuming the Negotiations on a Legally Binding Agreement on Forests in Europe was adopted by the FOREST EUROPE Expert Level Meeting in Bratislava on 6 December 2018, and subsequently endorsed by ministers responsible for forests in Europe. The signatories of FOREST EUROPE expressed readiness to resume the negotiations on a legally binding agreement on forests in Europe and agreed that further negotiations on a legally binding agreement on forests in Europe should take place and be finalized under the auspices of the UN system (https://foresteurope.org/wp-content/uploads/2017/08/Ministerial-Decision-on-Resuming-the-Negotiations-on-LBA_final.pdf).

The Updated set of pan-European indicators for SFM (the Annex of the Madrid Ministerial Declaration 25 years together promoting Sustainable Forest Management in Europe); FOREST EUROPE signatories committed themselves to use this set in forest policy, forest monitoring, as appropriate, and for collaboration with other sectors (https://foresteurope.org/wp-content/uploads/2016/11/III.-ELM_7MC_2_2015_MinisterialDeclaration_adopted-2.pdf).

Area of forests is stabilized and slowly increasing in last years and SFM practices are implemented and further developed in the pan-European region.

Ongoing preparation of the Draft Bratislava Ministerial Declaration for the 8th Ministerial Conference to be held in Bratislava on 28-29 October 2020, stressing the vital role of forests for European society and in achieving sustainable development globally.

Ongoing preparation of the Draft Bratislava Ministerial Resolution (working name Improve the adaptation capacities of forests towards climate change) for the 8th Ministerial Conference to be held in Bratislava on 28-29 October 2020, aiming at strengthening of transnational cooperation in the pan-European region on the adaptation of forests and forest management to climate change.

 - Lack of skilled workforce, deficits in decency of work in forestry, megatrends such as continued urbanization, digitalization, globalization as well as climate change

The activities and outcomes of the process FOREST EUROPE encourage mobilization of funds for financing the sustainable forest management, however, process as such does not provide funding.

Please describe the main challenges in mobilizing funds in a maximum of 250 words:

Costs linked to management of forests in signatory countries of FOREST EUROPE are primarily covered by the entities managing the forests (forest owners, companies managing forests) despite, they often undertake a number of missions (even required by law in some cases) which are not profitable by conventional economic criteria. However, governments also devote resources of staff and funds to support sustainable forest management. Governments use a number of economic instruments to help privately owned forests to achieve sustainable forest management and fulfilment of a number of specific objectives, including conservation of forest biodiversity, forest stand improvement, climate change adaptation, protected areas and afforestation. Countries often use grants, subsidies or tax tools for specific measures.
