- d) Raising awareness of the significance of forests, engaging in celebrating the IDF, and addressing related gaps and needs of the UNFF secretariat.





Major Groups and other Stakeholders (MGoS):

Training Workshop to strengthen their capacity to contribute to UNSPF implementation (Jan 2025)

- Developed joint MGoS workplan that builds on past experiences and draws from lessons learned from the 2017-2021 joint workplan

Intersessional activities / developments

Major global developments related to forest financing:

- Increase recognition of forests' significance in addressing global challenges
- The Amazon, Congo and critical forest biomes integrated programme under GEF 8th cycle, approved in February 2024, includes 28 countries, with a total of \$307 million grant from GEF
- As of December 2024, the GCF approved projects in the forests and land use sector totaling \$1.812 billion, including result-based payment of REDD+
- Global Biodiversity Framework Fund

Major challenges

- Despite ODA rise, funding to forest sector remain a small fraction of the total ODA
- Lack of data/ information on funding opportunities; growing fragmentation of the forest financing landscape; Long and complex procedures for accessing to multilateral funds; lack of enabling environment to attract public and private investments



Intersessional activities / developments

GFFFN activities

- In 2024, support was provided to 5 countries and 1 subregional entity.
- Currently, requests from 5 countries and 1 regional entity are pending due to lack of financial resources in UNFF Trust Fund

Clearing House

- By the end of 2024, Clearing House website contains:
 - Over 300 entries in the 3 databases (financing opportunities: 164; learning materials: 109; and good practices and lessons learned: 44)
 - 10 Quarterly Highlight has been published by the UNFF Secretariat. Preparing the launch of webinar series will be held in the coming month, in collaboration with CIFOR, and more to come with other CPF members and partners.

Proposals for discussion at UNFF20

- Inviting Members of the Forum and others in a position to do so, to provide voluntary contributions to the Forum Trust Fund to enable the GFFFN to respond and provide the requested support in an effective and timely manner.
- Inviting the Forum Secretariat to explore additional avenues for cooperation and strategic partnership with relevant UN and non-UN data providers on forest financing with the objective of facilitating access of countries and stakeholders to comprehensive, and reliable data on forest financing flows, opportunities, knowledge and best practices in a one-stop-shop.



 - Finalization of the reporting format
 - Revision of the explanatory notes on reporting
 - Testing of the online reporting platform
 - Preparatory work for the next Global Forest Goals Report

Submission of the voluntary national reports through the online platform

Preparatory process:

- Research and selection: (easy to learn and use; cost-effective; compliant with the UN ICT standards; desired functionality)
- Setting up and translation into FR and SP
- Testing with Advisory Group
- Revision of the Explanatory notes for reporting
- Finalization and launch January 2025

Deadline for submission: 30 June 2025

- Will make use and further promote the Global Core Set of forest related indicators.



Priorities and challenges for the Trust Fund

- Voluntary contributions are essential in supplementing RB resources, especially during the current liquidity crisis.
- Scaling up the GFFFN, the Clearing house mechanism and communication and outreach is limited due to inadequate resources.
- Securing funding for travel of representatives to UNFF sessions is a major challenge, and it has not been possible to provide air tickets or DSA.
- Sustained, predictable and adequate resources, both human and financial, are critical for UNFFS to carry out its core activities.
- As stressed in the Information Paper on Workload, Needs and Gaps of the UNFFS, Trust Fund resources should only be utilised for temporary and short-term hires/activities/deliverables to supplement UNFFS RB – not to support long-term staff/core mandated activities.
