### Joining Forces for Forests:

## CPF Joint Action to Advance Global Forest Goals

### I. Background

As part of the International Arrangement on Forests (IAF), the Collaborative Partnership on Forests (CPF) is a voluntary interagency partnership of 16 leading international organizations and plays a key role in advancing the implementation of the United Nations Strategic Plan for Forests 2030 (UNSPF) and the achievement of the Global Forest Goals (GFGs). Through coordinated actions, joint initiatives, and knowledge sharing, CPF strengthens cooperation among international forest-related organizations to maximize their collective impact.

CPF is currently implementing 12 enabling and thematic Joint Initiatives (JIs) to support Member States in key areas, including forest policies, policy coherence, emerging issues, science-based decision-making, resource monitoring, reporting, education and financial flows in alignment with the GFGs<sup>1</sup>. Formulated to address dynamic and complex challenges, these JIs rely on continuous coordination, adaptability and innovation to meet the demands of a changing policy landscape.

The UNFF19 Omnibus Resolution and the High-level Segment Declaration contain numerous provisions regarding the work of the CPF and its member organizations. These signify the critical importance of the work of the CPF and its members in making progress towards achievement of the objectives of the IAF. To further strengthen the Partnership, several invitations in the UNFF19 omnibus resolution are addressed to the governing bodies of the CPF member organizations, including to strengthen collaboration and support to the work of the CPF, and integrate the UNSPF and the GFGs into the plans and operational programmes of work of the CPF members.

The thematic priorities for the twentieth and twenty-first sessions of the UNFF (UNFF20 and 21) are GFGs 1, 3 and 5<sup>23</sup>, and provide opportunities for the CPF to focus its support to their accelerated progress. Global Forest Goal 1 aims to reverse forest loss through sustainable forest management.

This goal has been echoed by global initiatives and governments with commitments to end deforestation and restore forests. At UNFF19, Member States expressed serious concern about ongoing deforestation and its links to climate change, land degradation, and biodiversity loss, while also recognizing national efforts to combat these issues<sup>4</sup>.

Countries have made some progress toward Global Forest Goal 3, with protected forest areas increasing from 17% to 18% between 2010 and 2020<sup>5</sup>. However, progress varies by region, and many countries report challenges such as limited resources and skilled staff, which hinder their ability to enforce and implement forest laws effectively.

On GFG5, countries report that forest issues are increasingly included in development and poverty reduction strategies, and their role in sustainable development is gaining recognition. However, it's unclear if these efforts fully integrate forests into land-use planning, as forests are often undervalued, the forestry sector is minimized, and other priorities like food, energy, and social issues tend to take precedence.

This side event will highlight concrete actions taken by the CPF in support of GFGs 1, 3, and 5 through its Joint Initiatives. The side event will bring together representatives from UNFF Members and CPF member organizations, offering a platform for exchange and partnership-building.

## **II. Objectives and modalities of the event**

The main objectives of the event are to provide an opportunity for dialogue and exchange with the UNFF Members, in particular to discuss and showcase how CPF collaborative actions contribute to the advancement of GFG1 (Reversing forest loss and degradation), GFG3 (Increasing area of protected forests and proportion of forest products from sustainably managed forests), and GFG5 (Promoting governance frameworks for sustainable forest management).

The Member State speakers of the event will address the following guiding questions:

- How could the CPF enhance coherence, collaboration and synergies, including through its Joint Initiatives, to support Member States and accelerate progress towards the achievement of the Global Forest Goals by 2030?
- What are your country's next steps to strengthen collaboration and support to the work of the CPF to address pressing global challenges on forests?

The event will be held in person in Conference Room 7, UNHQ, New York, and conducted in English with no simultaneous interpretation. The meeting will be open to all UNFF20 participants.
