Voluntary National Report to UNFF

Voluntary National Report on progress towards the implementation of the UN Strategic Plan for Forests 2017–2030, the UN Forest Instrument and Voluntary National Contributions

Thank you for taking the time to complete the voluntary national report to the UN Forum on Forests (UNFF).

Before you start, please take note of the following important information:

- 1. The Economic and Social Council, in its resolution 2022/17, requested the UNFF secretariat to amend the format for voluntary national reporting to the Forum, taking into account the suggestions and proposals received from members of the Forum, and conduct a pilot phase for the use of the refined format. In the same resolution, the Council invited the Forum to consider establishing an advisory group on reporting. It further requested that the secretariat explore options for establishing an online reporting platform for the Forum, recognizing the need for streamlined reporting and minimizing the reporting burden, including the challenges faced by developing countries.
- 2. In fulfilling this mandate, the UNFF Secretariat has amended the format, taking into account the suggestions and proposals received from Members of the Forum and in consultation with the advisory group on reporting. The secretariat has also established an online reporting platform for the submission of voluntary national reports to the Forum.
- 3. The amended format is structured around the Global Forest Goals and targets of the UN Strategic Plan for Forests 2017–2030 (UNSPF) and builds on the previous format that was used for reporting to the UNFF15.
- 4. The amended format consists of twelve sections, each with several questions:

 - 3. Progress toward Global Forest Goal 2 and associated targets

 - 7. Progress toward Global Forest Goal 6 and associated targets
 - 8. Self-assessment of progress toward the Global Forest Goals and targets
 - 9. Voluntary National Contributions

Brief description:

By 2030, Botswana will reduce Forest degradation by 10% in-order to achieve the Land Degradation Neutrality target. The country will achieve this by planting 2 million trees in homesteads, road reserves, open spaces, establishment of community woodlots, reducing area burned by wildfire by 20% from 2014/15 average area burned and reducing spread of Prosopis invasive species by 10 %. Carbon stocks will be improved by 1% across all land types by preventing land use and land cover change. The 409 540 ha of protected areas will be maintained during opening up of forest reserves for eco-tourism activities.

Progress to date:

The Government of Botswana promotes tree planting in degraded areas for restoration, around homes and in institutions through the commemoration of tree planting days, International Day of Forests and Desertification and Drought day annually.

The establishment of mokolwane(Hyphaene petersiana) plantation in Shorobe has started with fencing and drilling of borehole done through Government National Environmental Fund. Communities are engaged to remove prosopis with value addition of charcoal production in the Tsabong district. Academic institutions such as the University of Botswana are also engaged in the mapping of prosopis.

The Government of Botswana is undertaking Holistic Range Management initiatives across the country to promote good rangeland through grazing management, reseeding of rangelands with palatable perennial grasses and management bush encroachment.

Various stakeholder engagement initiatives are undertaken to increase community fire preparedness and reduce response time to fire incidences. Early season prescribed burning interventions in some areas have helped to reduce area burnt, and such efforts will be intensified in other fire prone areas
