Voluntary National Report on progress towards the implementation of the UN Strategic Plan for Forests 2017–2030, the UN Forest Instrument and Voluntary National Contributions

Thank you for taking the time to complete the voluntary national report to the UN Forum on Forests (UNFF). Before you start, please take note of the following important information:

- 1. The Economic and Social Council, in its resolution 2022/17, requested the UNFF secretariat to amend the format for voluntary national reporting to the Forum, taking into account the suggestions and proposals received from members of the Forum, and conduct a pilot phase for the use of the refined format. In the same resolution, the Council invited the Forum to consider establishing an advisory group on reporting. It further requested that the secretariat explore options for establishing an online reporting platform for the Forum, recognizing the need for streamlined reporting and minimizing the reporting burden, including the challenges faced by developing countries.
- 2. In fulfilling this mandate, the UNFF Secretariat has amended the format, taking into account the suggestions and proposals received from Members of the Forum and in consultation with the advisory group on reporting. The secretariat has also established an online reporting platform for the submission of voluntary national reports to the Forum.
- 3. The amended format is structured around the Global Forest Goals and targets of the UN Strategic Plan for Forests 2017–2030 (UNSPF) and builds on the previous format that was used for reporting to the UNFF15.

Action (short title):

Upscaling Green Pakistan Programme

Brief description of the action:

Upscaling Green Pakistan Programme (Phase-I), launched in 2016, was initiated to revive and enhance forest cover and conserve wildlife resources across Pakistan, with a particular focus on arid and semi-arid regions. As a flagship initiative of the Government of Pakistan, the programme aimed to combat environmental degradation, restore critical ecosystems, and strengthen resilience to climate change impacts. Under this initiative, a national target of planting 3.28 billion trees by 2030 has been established. The implementation strategy combined afforestation through sowing, assisted natural regeneration, and the distribution of planting material, executed in collaboration with federal and provincial forest departments as well as other implementing partners. The programme further aimed to create green employment opportunities, foster community engagement, and enhance institutional capacities in the forestry and wildlife sectors. Phase-I represented a significant step towards fulfilling Pakistan's obligations under international environmental agreements, including the UNFCCC, UNCCD, and CBD, while also contributing to the realization of the Sustainable Development Goals (SDGs).

Main results achieved for the action:

Under the programme 2.2 billion plants have been planted nationally in various ecological zones including, degraded forest lands, riverine belt, mangroves, and community lands. The third party consortium of International Union for Conservation of Nature (IUCN), World Wide Fund for Nature (WWF), and the Food and Agriculture Organization (FAO) has assessed plantation success rate ranging between 75% and 95%, varying by regiona and plantation models. Beyond increasing the tree cover, the programme also enhanced biodiversity conservation, supported livelihoods, and strengthened Pakistan's climate resilience.

Restoration of mangroves along the coastal areas of Pakistan

Brief description of the action:

Since the early 1990s, Pakistan has initiated mangrove restoration work along the Pakistan's coast through public, donor and private sector funding which is continuing till to date.

Main results achieved for the action:

Since the early 1990s, Pakistan has achieved a remarkable 300% increase in mangrove forest cover, making it the only country in the region with expanding mangrove ecosystems. This success is The successful restoration of mangroves has resulted in and increase in mangrove cover by 300% since 1990 as independently assessed by Institute of Space Technology and WWF Pakistan through temporal analysis using satellite and remote sensing techniques.

Under this action, national assessment of forest cover and carbon stocks was undertaken under the REDD+ Readiness Project funded by the Forest Carbon Partnership Facility (FCPF) through the World Bank.

Under this action, the national assessments were carried out in 2017 and 2021 using National Forest Monitoring Standards. The results revealed that forest carbon stock was 190 million tons in 2017 and enhanced to 366 million tons in 2021.

Brief description of the action:

The REDD+ Readiness Project implemented with support from Forest Carbon Partnership Facility (FCPF) through the World Bank. The project supported establishement of REDD+ mechanisms to comply with readiness requirements of Warsaw Framework for implementation of REDD+ in line with Article 5 of the Paris Agreement. The project aslo supported in the necessary technical and institutional capacity building, awareness and outreach.

Main results achieved for the action:

The project supported in the achievement of the following key outcomes:

- 1. Pakistan's National REDD+ Strategy was developed and published on UNFCCC website.
- 2. Robust National Forest Monitoring Systems (NFMS) were developed. Forest monitoring portals were established and operationalised at national and provincial levels together with capacity building. (www.nfmspak.org)
- 3. National Forest Reference Emission Level (FREL) was established and reviewed by the assigned experts by UNFCCC. The report is published on UNFCCC website.
- 4. Safeguard Information Systems were developed.

Land Degradation Neutrality Target Setting Programme Phase-II
Brief description of the action:
Pakistan established its Land Degradation Neutrality (LDN) targets in 2020 and formally submitted them to the UNCCD under Annex-II B. Building on this milestone, the country is now undertaking a process to refine and update its LDN targets with technical support from the UNCCD. This refinement focuses on the use of spatially explicit data, updated baselines, and improved methodologies to make the targets more measurable and actionable. The objective is to mainstream LDN targets into national and sub-national planning frameworks, ensuring their alignment with broader sustainable development priorities and international commitments, including the Sustainable Development Goals and climate change agreements. The refined LDN targets are expected to strengthen Pakistan's efforts to combat desertification, restore degraded landscapes, and promote long-term environmental sustainability and resilience.
Main results achieved for the action:
1. A dedicated National Working Group has been constituted to guide and support the LDN Target Setting Process. This multi- stakeholder group comprises representatives from relevant ministries, provincial departments, research institutions, and technical experts.
2. An Inception Workshop was organized on 21 May 2024, bringing together key stakeholders to review existing targets, discuss the integration of updated spatial data, and align the LDN agenda with national development priorities. 3. Provincial consultations are on-going for refining LDN targets.

Action (short title):
Development of National Forest and Landscape Restoration Plan

Brief description of the action:

The National Action Plan for Forest and Landscape Restoration (FLR) in Pakistan was developed by the Pakistan Forest Institute with FAO support, outlines a strategic framework to restore degraded ecosystems in alignment with global commitments such as the UN Decade on Ecosystem Restoration and SDGs. The plan was shaped through broad stakeholder engagement, including government, NGOs, academia, and communities. It aims to guide and coordinate FLR efforts across sectors by identifying priorities, mainstreaming restoration into national programmes, and enhancing livelihoods through ecosystem recovery. The Plan targets degraded forests, rangelands, marginal farmlands, and community woodlots using both mosaic and wide-scale restoration approaches. Three key areas include restoring landscapes, enabling policy and financing support, and strengthening institutional and technical capacity. Eleven strategic priorities and 56 actions are outlined for short, medium, and long-term implementation. The Plan also identifies province-specific targets and potential partnerships to mobilize resources and ensure sustainable restoration outcomes across Pakistan.

Main results achieved for the action:

The action plan targets restoration of 2.10 M ha degraded land and 1.20 M ha of degraded watersheds, Increased landscape resilience against climate impacts and restoration of 0.7 million ha of community forests, woodlots, irrigated plantations and linear plantations by 2045.

Action (short title):

Mangrove Restoration for Building Coastal Resilience

Brief description of the action:

The large scale restoration of mangroves is on-going through pulic, donor and private sector funding. Delta Blue Carbon Project has been initiated to restore over 350,000 hectares of degraded mangrove forests and tidal wetlands in the Indus Delta over the period of 60 years with expected potential to sequester 127 million tons of CO2eq. over the life time of the project. As a large-scale nature-based solution, the project demonstrates the role of blue carbon ecosystems to contribute to climate action, sustainable development, and coastal resilience building.

Main results achieved for the action:

Since its launch, the project has restored over 85,000 hectares of degraded mangrove forests, creating a buffer for coastal communities against sea-level rise, cyclones, and seawater intrusion, besides sequestering carbon for climate benefits. As one of the world's largest blue carbon projects, it exemplifies the nature-based solutions to advance climate adaptation, biodiversity conservation, and sustainable development.

The objective of this assesment report were;

- To analyze demand and supply of forests for provisioning a number of services such as, carbon and non-carbon benefits.
- To measure the role of forestry products and services in employment and livelihoods provision.
- To quantify the value of forestry products and services and its contribution in national GDP.

Main results achieved for the action:

Forests and plantations play an important role in supplying timber and fuelwood for meeting the demands of the ever-growing population. The total wood supply in the country is estimated at 52million cubic meter, out of which timber is 29% (15 million cubic meter) and fuelwood is 71% (37 million cubic meter). The government-managed forests provide 12% and private land supplies 88% of the total wood. Public forests provide 2% of timber and 16% of the fuelwood requirements in the country. On the other hand, plantations on private lands provide 98% of the timber demand and 84% of fuelwood demand.

The total wood demand in the country has been estimated at 69million3, of which, timber demand is 19 million cubic meter and fuelwood demand is 50 million cubic meter. About 65% of the timber is used by major wood-based industries and 35% is consumed by small wood-based industries. The household sector consumes 90%, the commercial sector uses 7%, and the industrial sector 3% of the total fuelwood.

A study by World Bank found that 80% of people living in rural areas depend on non-timber forest products to supplement their income. A careful estimate suggests that the direct employment in forestry related services is around 7% of the total employment. By adding the livestock, the number will go to around 10%. Across gender, livestock is the main source of female employment across the country. FAO, has estimated that around 600,000 workers are employed in the wood-based industries. The overall economic contribution of forestry sector goods and services to GDP has been estimated to be 11.48%.

Brief description of the action:

Sustainable Forest Management Project was implemented with support from the Global Environment Facility (GEF) and FAO. The project focused on strengthening institutional capacities and promoting best practices for sustainable forest use across selected sites in Khyber Pakhtunkhwa, Gilgit-Baltistan, and Sindh. Key interventions included the development of forest management plans, promotion of community-based forest governance, capacity-building of local stakeholders, and the introduction of tools for monitoring forest resources and biodiversity. The project emphasized participatory approaches, integrating traditional knowledge with scientific methods to improve forest productivity, biodiversity conservation, and climate resilience. Additionally, national guidelines on sustainable forest management were developed to support harmonized planning and implementation across provinces, in alignment with Pakistan's forest policy and climate change commitments.

Main results achieved for the action:

The Sustainable Forest Management Project delivered notable results in strengthening forest governance and conservation outcomes. Forest management plans covering critical ecosystems were prepared and implemented with the active involvement of local communities. Over 60 sites for Assisted Natural Regeneration were established, promoting natural forest regeneration on degraded lands. Institutional capacities were enhanced through training programs for forest officials and community members, while awareness campaigns fostered a stronger conservation ethic. The project also supported the establishment of Chilgoza Forest Conservation Committees and small-scale processing units, contributing to value addition and livelihoods and promoted ecotourism. Biodiversity assessments and the integration of SFM principles into provincial planning processes have laid the groundwork for scaling up sustainable practices in the country.

These plans, tailored for each province and region—including AJK, Balochistan, Gilgit-Baltistan, KP, Punjab, and Sindh aim to mainstream gender considerations into forest governance and climate actions. Key actions include ensuring women's meaningful participation in forest-related decision-making processes and institutional structures, such as the Provincial REDD+ Management Committees, with targets of 40–50% female representation in community-level initiatives. Efforts have been made to promote women's access to forest-based income-generating opportunities, such as non-timber forest products, eco-tourism, and agroforestry.

These events involved school children, universities, communities, and local leaders. Activities focused on the year's IDF theme, highlighting forest restoration, ecosystem services, and biodiversity.
- 2. Forest Awareness Campaigns and Media Outreach: The campaigns featured messages from public figures and experts on the role of forests in climate mitigation and sustainable development.

Brief description:
Large scale restoration of mangroves along the coast of Pakistan.
Main results achieved:
The successful restoration of mangroves has resulted in and increase in mangrove cover by 300% since 1990 as independently assessed by Institute of Space Technology and WWF Pakistan through temporal analysis using satellite and remote sensing techniques. Pakistan is the only country in the region, where mangrove cover is significantly increasing.
The Delta Blue Carbon Project (DBC) in Sindh is under implementation. It is one of the world's largest mangrove restoration initiatives, implemented through a public-private partnership. It aims to restore over 350,000 hectares of degraded mangroves and tidal wetlands, using carbon finance as a sustainable funding model with the potential to sequested 127 million tons CO2eq. over the period of 60 years.
To date, the project has restored over 75,000 hectares, generated 3.1 million carbon credits sold in carbon market. Sindh Forest Department earned share of US\$ 14.7 million. This income is reinvested in conservation and community development. The project has contributed to forest restoration, biodiversity conservation and SDGs.
