### Voluntary National Report on progress towards the implementation of the UN Strategic Plan for Forests 2017–2030, the UN Forest Instrument and Voluntary National Contributions

Thank you for taking the time to complete the voluntary national report to the UN Forum on Forests (UNFF).

- 1. The Economic and Social Council, in its resolution 2022/17, requested the UNFF secretariat to amend the format for voluntary national reporting to the Forum, taking into account the suggestions and proposals received from members of the Forum, and conduct a pilot phase for the use of the refined format. In the same resolution, the Council invited the Forum to consider establishing an advisory group on reporting. It further requested that the secretariat explore options for establishing an online reporting platform for the Forum, recognizing the need for streamlined reporting and minimizing the reporting burden, including the challenges faced by developing countries.
- 2. In fulfilling this mandate, the UNFF Secretariat has amended the format, taking into account the suggestions and proposals received from Members of the Forum and in consultation with the advisory group on reporting. The secretariat has also established an online reporting platform for the submission of voluntary national reports to the Forum.
- 3. The amended format is structured around the Global Forest Goals and targets of the UN Strategic Plan for Forests 2017–2030 (UNSPF) and builds on the previous format that was used for reporting to the UNFF15.
- 4. The amended format consists of twelve sections, each with several questions:

  - 8. Self-assessment of progress toward the Global Forest Goals and targets

#### Action (short title):

Adoption of the National Forest Programme (NFP) 2030 by the Government of the Slovak Republic. Elaboration and endorsement of the NFP's Action Plan 2025-2030. NFP's strategic objective III: Utilize the potential of trees outside forests (on agricultural land) in adapting landscape to climate change.

Forest area has been increasing, respectively is stable in Slovakia. However, some objectives set out in the NFP and measures identified in its Action Plan may contribute to the achievement of the Target 1.1.

NFP's specific target 3.1 aims at improving conditions for a transfer of agricultural land parcels, covered by trees, to forest land parcels and become forest land also in legal terms. There are estimated 0.2 – 0.3 million hectares (ha) of land which is registered in national cadastral system as agricultural parcels, but due to partial abandonment of agricultural management (throughout the past decades) this land has been a subject of natural forest expansion. As a consequence, such areas are covered by trees of various age, size, species, and with various tree cover density. Pursuant to the national legislation, such areas are legally considered as agricultural land, not being subject to forest management regulated by the Forest Act.

#### Main results achieved for the action:

In 2024, the area of forest land reached 2.030 million ha, of which forest stands accounted for 1.96 million ha. The long-term trend of increasing forest land area has continued. Since 2020 the area of forest stands has increased by around 5 500 ha. Forest cover reached 41.4% in 2024, it has increased by 0.5% since 2000. Another 0.2 – 0.3 million ha of agricultural land is covered by trees of various age, species, and with various tree cover with potential to be partly converted to forest land.

Since 2020 the area of forest stands has increased by around 5 500 ha. Forest cover reached 41.4% in 2024, it has increased by 0.5 % since 2000.

#### Action (short title):

Adoption of the National Forest Programme (NFP) 2030 by the Government of the Slovak Republic. Elaboration and endorsement of the NFP's Action Plan 2025-2030. Objectives, targets and measures related to carbon stock enhancement.

There are specific objectives and measures in the NFP and its Action Plan that may further enhance carbon stocks in soils and tree biomass:

NFP's specific target 1.1 To improve the effectiveness of implementing forest protection measures in the most threatened stands.

NFP's specific target 1.2 Transformation of stands with unsuitable tree species composition into more resilient mixed forests.

NFP's specific target 3.1 Improving the conditions for transfer of agricultural land, covered by trees, to forest land (described under the Target 1.1)

NFP's specific target 3.2 Promoting the implementation of agro-forestry systems at agricultural land which may increase carbon stock sequestered in trees outside forests.

#### Main results achieved for the action:

In 2023, carbon stocks in forests in living biomass, deadwood and forest soil reached the value of 511 million tonnes (3 million tonnes more than in 2020). The largest amount of carbon is stored in soil (270.5 million tonnes) and in aboveground tree biomass (167 million tonnes).

#### Action (short title):

Actions resulting from the EU and national legislation

#### Brief description of the action:

Forest carbon stock in Slovakia is a subject of the EU's LULUCF targets as follows:

- (1) for the period 2021-2025: "No-debit rule" which for forest land means to maintain emission levels under so called "Forest Reference Levels" (in case of Slovakia on the side of removals i.e. negative emissions)
- (2) for the period 2026-2030: national targets set out in the Regulation (EU) 2023/839. The 2030 Target for Slovakia was set as 0.504 Mt of CO2 e.q below average removals level 2016-2018 in LULUCF sector. To meet this emission target for 2030 (and emission trajectory 2026-2029), forests will have to make a major contribution to the LULUCF removals.

On the other hand, these ambitious targets may prioritize short-term carbon stock (CO2 removals) over the long-term stability of carbon sequestered in forests (forest management working towards stable, resilient and adapted forests).

Moreover, to implement the target 1.2, there is also an adequate legal and institutional framework in place, regulated mostly by Forest Act and Nature Conservation Act. Sustainability of forest resources is guaranteed by obligatory forest management plans for all forests in the country and their supervision by state administration.

#### Main results achieved for the action:

Preliminary calculations show that Slovakia is on a track to meet EU's LULUCF targets for the period 2021-2025, while meeting the targets for 2026-2030 seems to be more challenging.

# Target 1.3: By 2020, promote the implementation of sustainable management of all types of forests, halt deforestation, restore degraded forests and substantially increase afforestation and reforestation globally

#### Action (short title):

Close-to-nature forest management concept incorporated into the Forest Act and revised Nature Conservation Act limiting forest management intervention to close-to-nature methods in protected areas at defined level of nature protection.

#### Brief description of the action:

Close-to-nature forest management focuses on supporting natural processes in the forest to increase the stability and resilience of forest stands to climate change, minimizing the need for artificial regeneration and promoting biodiversity. The obligation to apply close-to-nature forest management in areas of the third level of nature protection (out of five levels, the fifth level is the most strict protection) was introduced by an amendment to Act No. 543/2002 Coll. on Nature and Landscape Protection. This amendment was adopted in 2019 and effective from 2020.

The Forest Act defines close to nature forest management as follows: individual tree selection or group selection at small scale irregular plots up to 0.2 hectare, on slopes above 40% it allows strip shelterwood system with width up to one tree-height and up to 1.5 hectare.

#### Main results achieved for the action:

Currently, close-to-nature forest management is applied at approximately 4% of the forest area in Slovakia. Specifically, this accounts for 90,000 hectares. In addition, about 230,000 hectares are subject to the obligation to apply close-to-nature forest management as a result of new legislation.

Action (short title):
New legislative acts related to EU Deforestation Regulation (EUDR)
Brief description of the action:
The Slovak Parliament approved a new law - the Act No. 81/2025 to ensure the implementation of the EUDR (the Regulation (EU) 2023/1115 of 31 May 2023 on the making available on the EU market and the export from the EU of certain commodities and products associated with deforestation and forest degradation (EUDR)) at a national level. The new Act also amends existing law - the Forest Act and the Nature and Landscape Protection Act.
Main results achieved for the action:
The approved new legislation defines the obligation of Slovakia to designate an assigned authority responsible for implementing the obligations arising from the EUDR that aims to prevent products linked to deforestation and/or forest degradation from being placed on or exported from the EU market.  The amendments provide procedure for carrying out supervision and imposition of measures ensuring the obligations set out in EUDR, including applying sanctions for breaching the obligations.  The amendments to the Forest Act and Nature and Landscape Protection Act should also amend the provisions necessary for determination of the origin of wood.

Action (short title):

Adoption of the National Forest Programme (NFP) 2030 by the Government of the Slovak Republic. Elaboration and endorsement of the NFP's Action Plan 2025-2030.

The NFP headlined "Forests for Society" sets its vision to promote sustainable forest management through forest governance based on timely and accurate information, cross-sectoral cooperation, interdisciplinary approach and stakeholder participation at all levels, and thus contribute to sustainable development, protection of biodiversity, and human wellbeing. The vision should be achieved through 31 specific objectives grouped into 17 strategic goals. The objectives are classified in five thematic categories: Forests and climate, Forests and timber, Forests and new technologies, Forests and society, and Forests and public policies.

NFP's Strategic Goal II includes the ambition to expand close-to-nature managed forests to 500,000 ha by 2030, which represents 25% of the total forest area in Slovakia.

#### Main results achieved for the action:

The process of developing the National Forest Programme 2030 started in 2019. It was adopted by the Government of the Slovak Republic in March 2024. The NFP Action Plan was endorsed in December 2024.

# Target 1.4: The resilience and adaptive capacity of all types of forests to natural disasters and the impact of climate change is significantly strengthened worldwide

#### Action (short title):

Adoption of the National Forest Programme (NFP) 2030 by the Government of the Slovak Republic. Elaboration and endorsement of the NFP's Action Plan 2025-2030.

NFP contains the following specific objectives and measures related to the Target 1.4:

NFP's Specific target 1.1: Improve effectiveness of forest protection measures to slow down decay of the most vulnerable forest stands.

NFP's Specific target 1.2: Convert 10% of forests with inappropriate tree species composition to more resilient mixed forests.

NFP's Specific target 1.3: Ensure maintaining the gene-pool of forest tree species.

To protect forests from further decline, measures and objectives are aimed at fundamental change of tree species composition on at least one third of the current area of Norway spruce and Scotch pine forests (approx. 100,000 ha) with a particular focus on artificially established monocultures in sites unsuitable for these tree species. Regulations regarding transfer of genetic material are being adjusted to account for changing climatic conditions and ensuring genetic pool of forest tree species for future reforestation.

Objectives and targets of the NFP aim at implementation of a comprehensive forest health monitoring system to identify risks (Strategic objective X; Specific goal 1.1: Improve the effectiveness of the implementation of forest protection measures in the most endangered stands).

#### Main results achieved for the action:

More resilient deciduous (46.7%), predominantly deciduous (8.6%) and mixed forests (20.1%) prevail in forest stands; their total proportion was 75.4% in 2024. The share of coniferous and predominantly coniferous forests was 24.3% and has decreased by 3.5% since 2015. In 2024, the average defoliation of coniferous trees was 39.1% and deciduous trees 22.6%, showing a slight improvement in forest health in the last two years.

#### **Global Forest Goal 1 Challenges**

### 9. What are the main challenges in achieving Goal 1 in your country? Please limit your answer to 250 words.

Slovakia faces several challenges in achieving goals related to forest area expansion, carbon stock increase, sustainable management, deforestation prevention, and forest adaptation to climate change.

Slovak forests are vulnerable to climate change effects like longer periods of drought, heatwaves and storms. These factors contribute to the bark beetle infestations and the decline of especially spruce and pine forests, but damaging also broadleaved tree species.

While there are programs supporting close-to-nature forestry and forest restoration, financial incentives for forest owners remain limited. Complexity of operations, limited road network, higher costs along with fragmented ownership and complex administrative procedures complicate the effective implementation of transformation mechanisms. Expansion of natural forest regeneration faces several obstacles, as well. While the share of natural regeneration has remained stable at around 40 %, its full potential is not being utilized due to unsuitable tree species composition of mature stands, damage to young seedlings by ungulate game, and in some places also due to invasive vegetation or

short regeneration periods.

Increasing demands for biodiversity protection in managed forests and expansion of non-intervention zones towards managed forests create tensions between conservation efforts and interests of forest owners and managers, and people living in rural areas who depend on forestry and forest based sectors. This conflict complicates timely implementation of forestry measures and slows down the adoption of sustainable solutions.

Investment support will contribute to more modern, efficient and environmentally-friendly forest management practices.
Main results achieved for the action:
Small enterprises´ access to financing has been improved and subsidy programs for investments in sustainable forest management have been expanded. Support for provision of non-productive forest functions (https://www.apa.sk/lesy-deminimis) doubled from 3 mil. € in 2020 to 6 mil. € in 2022 and 2023.

In 2020, Ministry of Agriculture and Rural Development of the Slovak Republic launched the project "Delicacy from the forest" supporting the sale of game meat. This project focuses on the processing and sale of wild meat originating from the local wild, supplied by the state forest enterprise "LESY SR" and hunting associations, in contrast to farmed wild animals' meat provided to our market from farms from abroad.

Another option for purchasing Slovak game meat is the web application developed by the Slovak Hunting Chamber. In this way, customers can buy fresh meat directly from the nearest hunting association.

#### Action (short title):

Support for the economic stability of the forestry sector

From 2020 to 2023, the effort in the forestry and forest-based sector was focused on improving economic performance, mainly by enhancing wood utilization, increasing added value in the wood-processing industry, and promoting sustainable forest management. Investments were also directed towards the modernization of forestry technologies and infrastructure. Through the Rural Development Program of Slovakia (2014-2022) and the Strategic Plan of the Common Agricultural Policy (2023-2027), € 98.3 million was allocated to support sustainable forestry practices, forest road networks, and reforestation efforts. Recently adopted National Forest Program 2025-2030 "Forests for Society" and its Action Plan are the key strategic documents guiding future investments in forestry, towards innovation, technological modernization and increasing the competitiveness of the sector.

#### Main results achieved for the action:

A 10.6% increase in fixed-price investments between 2022 and 2023. In 2023, the total revenues and earnings in the forestry sector of Slovakia, including forest managers and service providers, reached € 1,287.9 million, representing an 8.3% increase compared to 2022 and 48.7% increase compared to 865.8 mil. in 2020. The largest share came from sales of own products and services.

Forest sector in Slovakia provides jobs for a wide range of professionals. The forestry sector (forestry entities) directly employ roughly around 17.1 thousand workers, of which 7.85 thousand employees and 9.25 thousand other self-employed persons or one-person Ltd.

Biodiversity commitments

By adopting the EU Regulation 2024/1991 on Nature Restoration, Slovakia is obliged to fulfilling several objectives related to strengthening the protection and restoration of biodiversity. By 2030, at least 30% of habitats listed in Annex I, which are not in good conditions, must be restored, with this target increasing to 60% by 2040 and 90% by 2050. Restoration efforts should prioritize Natura 2000 sites, ensuring that protected areas receive focused attention. Additionally, Slovakia must prevent further deterioration of the habitats and achieve improvements at least seven out of eight established indicators for forest ecosystems. The Ministry of the Environment of the Slovak Republic is currently developing the National Nature Restoration Plan that outlines specific actions to implement these commitments effectively. These legally binding commitments are in line with the Kunming-Montreal Global Biodiversity Framework adopted at COP 15 of the Convention of Biological Diversity and its 2050 Goals and 2030 Targets.

#### Main results achieved for the action:

Since 2020, biodiversity trends in Slovakia have developed in various directions. Despite the adoption of several strategic documents, such as the updated National Biodiversity Protection Strategy until 2020 and the related Action Plan, the loss of biodiversity and ecosystem degradation remain a challenge. Although objectives were set, including stopping the deterioration of species and habitats and restoring 15% of degraded ecosystems, the implementation of these measures has often been insufficient.

Slovakia has a long tradition in applying sustainable forest management practices and is making incremental progress especially in introducing participatory mechanisms and internationally recognized goals into strategic forestry planning (NFP). To enhance forest-based economic, social and environmental benefits, more emphasis should be placed on clear policies, innovations, digitalization, reduction of bureaucratic processes, supporting measures to forest owners and communication with the public.

The economic performance of the forestry sector is influenced by fluctuations in timber prices, a decline in logging volumes, and increased operational costs.

Although financial incentives are allocated through the Rural Development Program and the CAP Strategic Plan (2023-2027), small forestry enterprises face bureaucratic obstacles in accessing funds.

Given the current state of public policies and communication, lacking long-term vision and consistency towards target groups, public awareness of the importance of holistic approach to forestry and managing forests is not sufficient.

In the field of forest biodiversity protection, administration of national parks has been undertaking significant changes since 2021 with the aim to align the whole system of their protection with an international (IUCN) criteria. As a consequence, this measure will lead most likely to the enlargement of the share of strictly protected areas in the national parks. The measure also includes shift in land management responsibilities for the state-owned forest land in the national parks - the administration and management of the land (mostly forests) was transferred from state forest authorities to nature conservation authorities.

The issues of the forest products from sustainably managed forests are addressed in the Thematic area 2 "Forests and Wood" of the new NFP and its Action Plan 2025-2030. NFP contains following specific objectives and measures related to forests products:

Specific target 4.1 To improve the qualitative structure of raw wood assortments supply and increase its domestic consumption.

Measures:

- Increase the share of raw wood (especially the highest quality assortments) sold through electronic auctions and public auctions,

Forestry measures in EU Rural Development Policy (Common Agricultural Policy) / EU Recovery and Resilience Plan

The major source of public financial support comes from EU funds, mainly the Common Agricultural Policy (CAP). Current CAP Strategic Plan provides specific forestry measures to support implementation of close to nature forestry (25 mil. EUR) and forest restoration measures in forests damaged by natural disturbances and the prevention measures in already established forest stands (20 mi. EUR). These two measures together account for almost half of the CAP SP resources allocated for forestry for the programming period 2023-2027. Roughly, the other half of the allocated resources for forestry measures should support small forest holders, investments to water retention, and compensations for nature protection restrictions and forest-environmental measures.

Other amount of some 40 mil. EUR shall be made available from revised EU Recovery and Resilience Plan for Slovakia (revision under process). These measures shall support adaptation of forests to climate change in the framework of sustainable forest management.

In general, forestry activities on the ground (such as obligatory forest regeneration, tending and protection of young forest stands) are funded by forest owners / holders themselves regardless ownership of a forest. Forest management plans are obligatory for all forests in the country; these are procured and funded from public resources.

#### Main results achieved for the action:

The funding (after 2020) was provided from previous CAP programming period (2014-2020) mainly to restoration and regeneration of forests after natural disturbances. In total, the public resources to support forestry were at 47.26 mil. € in 2020 (including COVID pandemic measures) and 31.1 mil. € in 2023.

#### Brief description of the action:

Support from the state budget (state aid) has been provided for provision of forest ecosystem services other than wood and non-wood production (so called non-productive forest functions). This financial support has the nature of direct payment to forest holders completing silvicultural operations according to a forest management plan, leading to provision of ecological functions (such as protection of soil, regulation of water cycle, regulation of climatic conditions) and social functions (e. g. positive impact on human health, cultural function, educational function, recreational function, biodiversity protection, and protection of water sources).

#### Main results achieved for the action:

Since 2017 on, there was a total amount of almost 36 millions of euros, as state aid, allocated to forest owners (holders) to support fulfilling non-productive functions of Slovak forests. Since 2020, the support doubled from 3 mil. € during the last three years amounting to 6 mil. EUR per year. This financial support recently falls under a new state aid scheme, based on the current Act on Providing Subsidies in Agriculture.

Implementing the EU Deforestation Regulation (EUDR) at a national level

The Slovak Parliament approved a new law - the Act No. 81/2025 to ensure the implementation of the EUDR (the Regulation (EU) 2023/1115 of 31 May 2023 on the making available on the EU market and the export from the EU of certain commodities and products associated with deforestation and forest degradation (EUDR)) at a national level. The new Act also amends existing law - the Forest Act and the Nature and Landscape Protection Act.

The approved new legislation defines the obligation of Slovakia to designate an assigned authority responsible for implementing the obligations arising from the EUDR that aims to prevent products linked to deforestation and/or forest degradation from being placed on or exported from the EU market.

The amendments provide procedure for carrying out supervision and imposition of measures ensuring the obligations set out in EUDR, including applying sanctions for breaching the obligations.

The amendments to the Forest Act and Nature and Landscape Protection Act should also amend the provisions necessary for determination of the origin of wood.
