### Voluntary National Report on progress towards the implementation of the UN Strategic Plan for Forests 2017–2030, the UN Forest Instrument and Voluntary National Contributions

Thank you for taking the time to complete the voluntary national report to the UN Forum on Forests (UNFF).

The Economic and Social Council, in its resolution 2022/17, requested the UNFF secretariat to amend the format for voluntary national reporting to the Forum, taking into account the suggestions and proposals received from members of the Forum, and conduct a pilot phase for the use of the refined format. In the same resolution, the Council invited the Forum to consider establishing an advisory group on reporting. It further requested that the secretariat explore options for establishing an online reporting platform for the Forum, recognizing the need for streamlined reporting and minimizing the reporting burden, including the challenges faced by developing countries.
- 2. In fulfilling this mandate, the UNFF Secretariat has amended the format, taking into account the suggestions and proposals received from Members of the Forum and in consultation with the advisory group on reporting. The secretariat has also established an online reporting platform for the submission of voluntary national reports to the Forum.
- 3. The amended format is structured around the Global Forest Goals and targets of the UN Strategic Plan for Forests 2017–2030 (UNSPF) and builds on the previous format that was used for reporting to the UNFF15.

# Brief description of the action: Nationally, while the law does not allow deforestation resulting in total forest area decrease, Swiss forests currently have an area increase. According to the FAO Global Forest Resources Assessment 2020, Switzerland experienced a modest increase in forest area between 1990 and 2020. Main results achieved for the action: The total forest area in Switzerland grew from approximately 1.22 million hectares in 1990 to about 1.27 million hectares

The total forest area in Switzerland grew from approximately 1.22 million hectares in 1990 to about 1.27 million hectares in 2020, which represents an increase of around 4.1% over the 30-year period.

### Brief description of the action:

At national level, the main actions are adaptation measures including rejuvenation with more climate resistant species, improvement of the protective forest structure, combatting pests and increasing the sustainable wood use in buildings. These actions are also promoted at the international level.

### Main results achieved for the action:

In 2017, Switzerland's removals from forest land were 3.2 million tons CO2/year. Total net removals from LULUCF for the same period were 1.6 million tons CO2/year. (CRF Table 4 2019). In 2017, the net removal due to harvested wood products was of 166 kt CO2 (CRF table 4 Gs1). Due to climate change effects and forest age structure, the carbon sink in Swiss forests is declining.

Switzerland contributes significantly to multilateral funds and programs that directly or indirectly support forests, including through climate and biodiversity finance. Some examples are below.

Swiss "Forest Policy 2020" and "Forest Policy: objectives and measures 2021-2024":

### Main results achieved for the action:

1.4. At national level, both forest tree species and structure are being modified based on scientific research, stakeholder participation, and bottom-up governance structures. Communities and forest owners together with researchers and governmental entities are engaging in trials, as well as acting together in forests where climate damage has occurred. The federal government is improving the information exchange via new technologies for mapping and providing technical inputs to decision making on the ground. The 2017 revised law allows for taking measures to combat invasive species such as the recently increasing Asian longhorn beetle population. The law also foresees measures to promote native and sustainably produced wood in the Swiss building sector.

### Action (short title):

Technical and scientific actions for forest adaptation in Switzerland

The Swiss Federal Office for the Environment (OFEV), with the Forest, Snow and Landscape Institute engaged in a Forest and Climate Research Program from 2009-2018. Among others, the conclusions were the following: while the global temperature since 1880 rose of 0.85 degrees C, in Switzerland, it rose 1.8 degrees C for same period. By 2100, the increase in temperature in Switzerland is expected to be of 4.8 degrees C (over 1980-2009 average).

Basic considerations for actions on a national level:

- By 2050, the danger of reduced forest protective functions is expected, obliging to act now in order to be prepared
- The selection of future resilient species is already considered today, to be integrated into forest management regimes, for example silver fir (Abies alba), Douglas fir (Pseudotsuga menziesii), Sequoia (Abies grandis), oak (Quercus petraea and Q. robur)
- Protection forest is in danger due to advanced age structure, drought and increased fire danger, therefore rejuvenation and prevention of fires are needed.
- Expected higher incidence of storms makes rejuvenation measures essential, as shorter recuperation time will become the norm.
- There is a need to combat bark beetles incidence (lps typographus on Spruce and Anoplophora glabripennis on broadleaf).
- In Switzerland, due to important regional differentiation with ecological differences, measures are undertaken to mitigate habitat change forcing species migration, impacts in growth, mortality, and rejuvenation.
- Water management measures, as it is becoming generally dryer, with a higher mortality occurring in pine (Pinus sylvestris, P. mugo), silver fir (Abies alba), spruce (Picea abies), beech (Fagus sylvatica), and maple (Acer pseudoplatanus).

Forest owners and communities' ability to rejuvenate forests are challenged by low wood prices, high labor costs, and the resulting economic difficulties of the management enterprises. This contributes to endangerment and loss of the ecosystem services of forests through under-management and budgetary limitations.

### Brief description of the action:

The Swiss Agency for Development and Cooperation (SDC) supports forest-based livelihoods in developing countries, particularly through sustainable forest management and agroforestry programs.

The SDC plays a central role in implementing forest-related international cooperation, particularly through its thematical Section Climate, DRR and Environment. Key initiatives include:

- Contribution to UN-REDD to strengthen social forestry in the ASEAN region and Africa,
- Contribution to IUCN to support implementation of the Nature 2030 Programme,
- Contribution to the BioCarbon Fund Initiative Sustainable Forest Landscapes,
- Implementation of the Landscape Fire Management in the Western Balkan Programme.

### Main results achieved for the action:

- Swiss Agency for Development and Cooperation (SDC): Leads programs in forest-rich developing countries to improve livelihoods through sustainable forest management and agroforestry.
- Humanitarian Aid and Development Division: Integrates forest-based poverty alleviation into broader rural development strategies.

SDC Forest and Livelihood Programs: Funded under Switzerland's development cooperation budget. Estimated allocation: Part of the CHF 559 million, though not disaggregated specifically for poverty reduction.

Swiss Agency for Development and Cooperation (SDC) funds forest-based livelihood projects in countries like Nepal and Bolivia/Peru, Armenia, North Macedonia and the ASEAN Region.

These projects integrate forest conservation with income generation, often through agroforestry and community forest management.

### Action (short title):

Increase Access of Small-Scale Forest Enterprises to Financial Services

- Swiss International Cooperation: Through the SDC and SECO (State Secretariat for Economic Affairs), Switzerland supports small-scale forest enterprises in developing countries by:
- · Facilitating access to microfinance and credit.
- Supporting value chain integration and certification schemes (e.g., FSC).
- Climate & Innovation Act (2023): Although focused on domestic emissions, it includes financial incentives for innovation in forest-related sectors, indirectly supporting small enterprises

- State Secretariat for Economic Affairs (SECO): Supports forest-based SMEs in developing countries through trade facilitation, value chain development, and access to finance.

Provides equity and debt financing to forest-related SMEs in developing countries.

The protection of population and infrastructure is very important for the Swiss population. Biodiversity is the basis for human life. Therefore, all these actions contribute to a better livelihood.

It is important for the Swiss forest industries to sell wood products on the European markets. Due to the high value of the Swiss franc, it is getting more difficult.

Another challenge is the structure of forest ownership; the average property area of the 250'000 forest owners in Switzerland is 0.6 hectare.

Besides the wooden products, the pricing of the forest ecosystem services has no tradition – the services are considered free of charge by the society.



1. Rising Temperatures

Switzerland has experienced a 2°C increase in average annual temperature since pre-industrial times 1.

This warming is more pronounced in Alpine regions, accelerating ecological shifts.

2. Tree Species Shifts

Spruce and beech, two dominant species, are increasingly struggling in their current habitats.

Warmer, drier conditions are favoring thermophilic (heat-tolerant) species, leading to changes in forest composition.

Drought Stress

Southern regions like Valais and Ticino are already experiencing severe drought impacts.

Drought weakens trees, making them more vulnerable to pests and diseases.

4. Increased Pests and Diseases

Warmer conditions support the spread of invasive insects and pathogens, such as bark beetles.

These outbreaks can cause widespread tree mortality and economic losses.

5. Forest Fires

Higher temperatures and drier conditions increase the risk of wildfires, especially in southern Switzerland.

Fires threaten biodiversity and reduce the protective function of forests.

6. Reduced Ecosystem Services

Forests may become less effective at providing key services, such as:

Carbon storage

Protection against natural hazards (e.g., avalanches, rockfalls)

Biodiversity support

Wood and bioenergy production

Climate change introduces high variability and unpredictability, making forest management more complex.


