Excellency,

With the reference to your letter dated 28 September, allow us to express our deep appreciation in your reappointment of us as Advisors to the consultation process concerning the ways to enable the participation of Indigenous Peoples' representatives and institutions in meetings of relevant UN bodies on issues affecting them. We are grateful for your support in the process, including the convening of the informal launch briefing on 3 October 2016, at United Nations in New York.

The launch briefing provided a valuable opportunity for us to hear views from Members States and Indigenous Peoples on our proposed roadmap and approach to the consultation process. The indicative roadmap for meetings is as follows:

- 14<sup>th</sup> and 15<sup>th</sup> December
- 30<sup>th</sup> January to 1<sup>st</sup> February
- 27<sup>th</sup> and 28<sup>th</sup> February
- The weeks of the Permanent Forum, 24<sup>th</sup> April - 5<sup>th</sup> May (specific dates to be confirmed, depending on the schedule of the forum)

After these discussions a draft resolution would be finalized and adopted by the General Assembly as set out in General Assembly resolution 70/232.

It is our view that a successful outcome can only be achieved in partnership together with Member States and Indigenous Peoples. It is therefore important that the process remains inclusive as we have recommended in the letter forwarding the final compilation (8<sup>th</sup> July).

As there were also many requests for more time to consult nationally with Indigenous Peoples, it is good to have time for this during the autumn. Also many delegations are small and in that way it is better to have the actual discussions start only when the time consuming Third Committee is over.


