# DPA's contribution to the Tenth Session of the UN Permanent Forum on Indigenous Issues

1. At its tenth session in 2011, UNPFII will review its recommendations in relation to (a) Economic and Social Development; (b) Environment; (e) Free, Prior and Informed Consent.

There were no specific recommendations to DPA.

2. Given the Forum's recommendations for the adoption of policies on indigenous peoples issues, please specify whether your agency has: (a) a policy or other similar tool on indigenous peoples' issue; (b) recent programmes on indigenous peoples' issues; (c) budgetary allocations for indigenous peoples' issues; and (d) projects/activities on indigenous peoples' issues.

DPA is the UN's lead department for political analysis, peacemaking and preventive diplomacy and is often called upon to assist governments to address political or institutional crises, social tensions, or controversies with neighbouring States.

As part of its policy on mediation, DPA has incorporated the "UNDG Guidelines on Indigenous Peoples' Issues" into the information package for Special Envoys and mediators. The guidelines provide them with information on the international human rights framework for the UN's work on indigenous issues and also provide practical advice on designing programmes with a special focus on indigenous issues. The guidelines are extremely important as they were issued after the adoption of the United Nations Declaration on the Rights of Indigenous Peoples by the General Assembly on 13 September 2007. The Declaration specifically calls upon the organs and specialized agencies of the United Nations system to contribute to the full realization of its provisions.

DPA hired an expert on indigenous/land issues to support the work of the Mediation Support Unit's Stand-by team of experts. His initial assignment was to develop guidance material for mediators on land and indigenous issues, as well as make an inventory of possible upcoming needs for technical support in these areas.

### 3. Capacity-building programmes on indigenous issues?

As part of its staff development programme, DPA staff has the opportunity to attend training courses on conflict-prevention, preventive diplomacy and conflict-resolution. In connection to this, in August 2010, DPA's Focal Point on Indigenous Issues participated in the training on indigenous issues organized by the UN Country Team in Bolivia. The training included the participation of the Chair of the UN Permanent Forum on Indigenous Issues, Mr. Carlos Mamani.

With a view to develop in-house capacity on indigenous issues, DPA recommends to include DPA's Focal Point on Indigenous Issues in the next Training-of-Trainers on the UNDG Guidelines on Indigenous Issues.

#### 4. Does your agency have a Focal Point on Indigenous Issues?

#### 5. Conferences organized or supported by DPA on indigenous issues.

DPA helped the Conflict Prevention and Peace Forum (CPPF) organize a one-day meeting on the situation of indigenous peoples in Latin America. The meeting took place on 7 December 2010 in New York. CPPF, a programme of the Social Sciences Research Council (SSRC), was established to strengthen the knowledge base and analytical capacity of the United Nations in conflict prevention and management, peacemaking and peacebuilding.

The CPPF meeting had the participation of indigenous leaders, including Ms. Elisa Canqui, member of the UN Permanent Forum on Indigenous Issues and the former UN Special Rapporteur on the human rights of indigenous peoples, Professor Rodolfo Stavenhagen. Several DPA officials from the Americas Division and Policy and Mediation Division (PMD) as well as colleagues from UNDP, UNFPA, OHCHR and the Secretariat of the UN Permanent Forum on Indigenous Issues had the opportunity to attend the meeting.

The CPPF meeting had the following three objectives: a) evaluate the demands and issues of the indigenous peoples from Latin America; b) identify the main advances and challenges for the successful inclusion of indigenous peoples in the political, economic and social arenas; and c) examine in which way the international community could help Member States to address the demands of indigenous peoples.

In April 2010, DPA's Focal Point on Indigenous Issues participated in a workshop on the development of a UNDP regional strategy on indigenous peoples in Latin America. The workshop was held in San Cristóbal de las Casas, Chiapas, Mexico. The workshop included the participation of indigenous leaders from Bolivia, Guatemala, Mexico and Nicaragua as well as of UNDP officials working with indigenous peoples in several Latin American countries. During the workshop participants exchanged information on current UNDP projects with indigenous peoples in Latin America, covering both national and local community issues.
