Partnerships Activities

Highlights

1. Partnerships activities were organized at the Intergovernmental Preparatory Meeting for the thirteenth session of the Commission to foster discussions and exchange lessons learned on issues related to partnerships for sustainable development. In keeping with the policy-year focus on “practical measures and options to expedite implementation of commitments”, these partnerships activities highlighted “on-the-ground” experiences of partnership practitioners.

2. Partnerships activities featured “Partnerships in Practice” interactive discussions and a Partnerships Information Desk. The three interactive discussion sessions focused on practical issues related to implementation of partnerships. Some key elements for viable and effective partnerships were discussed, including: equitable partner roles and responsibilities; shared vision and commitment; realistic goals; effective coordination mechanisms; clear communication; good governance mechanisms; transparency and accountability; and challenges associated with monitoring and measuring progress in partnership implementation. The importance of gathering and sharing information on ongoing partnerships was also highlighted. The particular relevance of such information services to national-level efforts in coordinating and monitoring partnerships was noted.
