

Make changes to your UN Health Insurance plan in June



The UN Health and Life Insurance Section is pleased to launch the Annual Enrolment Campaign, from 1 to 30 June 2021. We have also launched a new insurance website.

Annual Enrolment Champaign

The Annual Enrolment Campaign is the time for you to make changes to your health insurance plan.

This year, the new UN insurance website makes it even easier to navigate the information for a well-informed decision on your health insurance plan for the next plan year, starting on 1 July 2021 through 30 June 2022.

New Insurance Website

On the website, you have access to tools such as Insurance Rate Simulators and guidance materials, including checklists, brochures, policy documents and benefit booklets.

Most importantly, visit the new Toolkit Pages for onboarding staff, active staff, or colleagues soon to retire, and many more. You will find timelines and detailed instructions for insurance-related processes such as enrolment, retirement and maintenance of the UNHQ-administered health and life insurance plans.

Another important update is the availability of interactive PDFs that allow you to easily fill out and submit insurance forms to hlis@un.org or ashi@un.org.

• Information Session on UN Medical Insurance Plan (in English): 17 June, 9 - 11 am (EST) and Information Session on UN Medical Insurance Plan (in French): 22 June, 9 - 11 am (EST)

The UN Medical Insurance Plan (UN MIP) covers locally recruited UN Secretariat staff, retirees, and their eligible family members, serving at designated duty stations away from the headquarters.
