Subject: GROUP LIFE INSURANCE WAIVER OF AUTOMATIC INCREASE

1. The insurance schedule of the Group Life Insurance Plan is adjusted once a year in accordance with the level of pensionable remuneration in effect at the time. Accordingly, all participants in the plan, other than those in the old Group Life Insurance Plan or those who have signed a waiver previously, are reminded that if their pensionable remuneration as of 1 July 1975 places them in a higher insurance bracket, insurance coverage will be automatically increased as from 1 July 1975, unless they sign and return the attached waiver to the Payroll Section, room 1947, before 13 June 1975.

2. The following is the schedule of insurance:

3. If participants who have elected to retain a lower face amount of insurance than their pensionable remuneration entitles them to should, at some future date, apply for the higher coverage, they will be required to furnish evidence of insurability satisfactory to the insurance company. The insurance company reserves the right to reject such applications.
4. The after-service benefits with respect to a participant who was not insured for the full amount to which he or she was entitled during the 10 years immediately preceding the date of separation will continue to be calculated in relation to the average of the face value of his or her policy during those 10 years.
