From the frontline of internal displacement: Panel hears impacted States

July 29 - Some 20 States shared their views with the Panel on its emerging recommendations in a virtual consultation held on July 29 in collaboration with the Panel's "Group of Friends". For the Panel, Co-chair Donald Kaberuka, who chaired the discussion, was joined by his colleagues Paula Gaviria Betancur, Nasser Judeh and Sima Samar. Ambassador Nasir Andisha, Permanent Representative of Afghanistan and Co-chair of the Panel's "Group of Friends," represented the Group.

In his opening remarks, Co-Chair Kaberuka recalled the consultations that the Panel has had since inception with more than 60 States. Over half of these States have been affected by internal displacement driven by the full range of causes including conflict, violence, disasters and the impacts of climate change. He underlined that, in the final phase of the Panel's work, the voices of States directly impacted by internal displacement remained even more critical.

Ambassador Andisha agreed with the importance of the feedback of impacted States. In looking ahead to when the Panel would submit its report, he reflected that this should not be seen as the end of the process but rather the moment when the global momentum on internal displacement issues should be strengthened.

"Although the report is about to be submitted, it is only the beginning. More work will be needed for the roll-out and implementation of the Panel's recommendations," said Ambassador Andisha.

Statements were then heard from States across the spectrum of the Panel's work and emerging recommendations. Drawing on their respective experiences on the frontline of the global internal displacement crisis, they expressed support for the priority that the Panel has placed on finding solutions. The sovereign responsibility of States for the issue and the importance of national political will, ownership and a concerted effort by governments at all levels were echoed. The roles of civil society and the international community were also acknowledged. Views were also expressed, a number of clarifications sought and support underscored for the Panel's recommendations on the establishment of a "Global Fund on Internal Displacement Solutions," creation of the position of a Special Representative of the UN Secretary-General on internal displacement and state-to-state engagement to support the capacities of governments, enhance coordination and strengthen national and international accountability in advancing solutions to internal displacement.

On behalf of the Panel, Co-Chair Kaberuka thanked the States for their candid views. He assured that the Panel will continue to reach out and give importance to the views and concerns of the States affected by internal displacement.

Panel sustains engagement with States on its conclusions

July 2 - With two months to go to the submission of its final report, the Panel has ramped up its stakeholder engagements to garner input on its emerging recommendations. On July 2, the Panel outlined to States the findings and recommendations it is considering for its report in a meeting with the Panel's "Group of Friends" (GOF) Member States chaired by the Co-Chair of the Group, Ambassador Nasir Andisha, Permanent Representative of Afghanistan to the United Nations in Geneva. Of the 30 States taking part in the meeting, nearly half were countries affected by internal displacement.

Ethiopia, Norway, Switzerland, the Netherlands, the United States of America and Nigeria spoke to the presentation by the Panel. In the plenary discussion which then followed, reflections were heard on the full range of issues the Panel outlined. Overall, there was convergence that the Panel initiative provides a "unique opportunity" to advance "real change" and "long-term solutions" for the world's internally displaced. The importance of ensuring that solutions are owned at both the national and local levels as national sovereignty was underlined. National capacity and ample and predictable financing to support all aspects of the response to internal displacement were also highlighted. With regard to the specific mechanisms, processes or arrangements that the Panel is considering to improve uptake, accountability and coordination of the issue, there was both support and encouragement to the Panel fully to explore how existing mechanisms would be optimized and enhanced.

Participants were assured that the final recommendations of the Panel will reflect the voices from the meeting as well as those from other consultations throughout the process.

July 12 - Some 20 NGOs were briefed by the Secretariat on the last stretch of the Panel's work and its emerging recommendations a meeting hosted by InterAction on July 12. As a whole, they were received positively, in particular the need for strengthened coordination and accountability in driving forward solutions for the world's internally displaced. In that regard, it was stressed that the views and needs of IDPs had to be placed at the heart of all solutions decisions. In the discussions relating to specific issues and recommendations, including the proposal for the establishment of a Global Fund on solutions and the creation of the position of a Special Representative of the Secretary-General (SRSG) on Solutions to Internal Displacement specific feedback was provided and questions for clarification posed, which the Secretariat responded to accordingly.

The meeting concluded with the following broad conclusions which have been drawn to the Panel's attention:

- IDPs and civil society should be at the center of decision making for solutions and IDPs should be considered the primary stakeholders as the affected population.
- The unique experience of IDPs should underpin data collection and analysis for internal displacement, and efforts should be made to build on existing data systems.
- The role of regional bodies and national actors is equally critical as that of HQ/global actors for advancing solutions for IDPs.
- To drive forward, the role of the proposed SRSG and other actors in the nexus space needs to be further explored.
- Accountability on solutions is required across all areas and relevant actors.
- The proposed Global Fund on Internal Displacement Solutions should address a significant gap in existing humanitarian and development funding mechanisms.
- Follow-up of the Panel's report and recommendations is crucial to maintaining momentum and driving solutions for IDPs.

Leaving no one behind: Panel participates in second Age, Gender, Diversity dialogue

July 22 - The Panel, represented by member Sima Samar and its Secretariat, benefited from a discussion with NGOs, States and UN agencies on Age, Gender and Diversity (AGD) in a roundtable on July 22 co-organized by the Women's Refugee Commission (WRC), Danish Mission in Geneva, Danish Refugee Council, Plan International and Save the Children. The event built upon the outcomes of an earlier AGD Dialogue, held in November 2020, and a joint AGD submission to the Panel with over 50 signatories comprised of NGOs and States.

The importance of mainstreaming human rights and AGD approaches throughout the Panel's report in order to achieve inclusive recommendations that reflect the rights of IDPs in all their diversities was underlined. In this connection, the voices and needs of IDPs were reiterated as central to all solutions processes and

decisions. As the majority of the world's IDPs are overwhelmingly women and children, the special risks and challenges faced by the two groups were given special attention including gender-based violence, education barriers and exclusion from participation in peace processes and decision-making. The need for improved data collection in order to obtain disaggregated data on gender, age, disability, among other criteria in different settings.

Concluding the session, Panel member Sima Samar highlighted that the internal displacement crisis is a shared responsibility across all actors. She assured participants that the "dignity of people" of all the different ages, gender and diversities is very much at the top of the Panel's agenda.
