HIS EXCELLENCY MR. SOVANN KE, AMBASSADOR AND PERMANENT REPRESENTATIVE, OF THE KINGDOM OF CAMBODIA TO THE UNITED NATIONS

First Part of the Fifth United Nations Conference on the

Least Developed Countries

(LDC5 Conference)

New York, 17 March 2022

Thank you, Mr. President, Mr. Secretary-General, Excellencies and Distinguished Delegates,

- 1. At the outset, I wish to thank the President of the General Assembly and the High Representative of the UN-OHRLLS for convening Part One of the Fifth United Nations Conference on the Least Developed Countries (LDC5 Conference) today, in accordance with the General Assembly Resolution A/76/L.39 of 23 February 2022.
- **2.** I also wish to congratulate H.E. Sheikh Mohammed bin Abdulrahman Al-Thani, Deputy Prime Minister and Minister of Foreign Affairs of the State of Qatar, for being elected as the President of the LCD5 Conference.
- **3.** Cambodia aligns itself with the statements of the Group77 and China, and the LDCs Group, delivered by Pakistan and Malawi, respectively, and I wish to make the following points in my national capacity:

To conclude, I would like to express my sincere thanks and appreciation to the Co-Facilitators, Ambassador Bob Rae, Permanent Representative of Canada and Ambassador Rabab Fatima, Permanent Representative of Bangladesh for steering the LDC5 Prep.Com and facilitating the draft DPoA successfully.
