In our capacity as Co-Chairs, we have the honour to invite you to the first session of the Preparatory Committee for the Fifth United Nations Conference on the Least Developed Countries to be held on 24, 25, 27 and 28 May 2021, in line with the General Assembly resolution 74/232B. The opening meeting scheduled from 10:00am-1:00pm on 24 May 2021 and the closing meeting from 10:00am to 1:00pm on 28 May 2021 will be held in-person. The rest of the meetings will be virtual to hold interactive and thematic panel discussions.

There will be further opportunities for Groups, Member States and other stakeholders to participate during the thematic panel discussions. Information on how to register the expression of interest to participate in the dialogues of the thematic sessions will be communicated in due course.

Please note that in line with continued restrictions on in-person meetings in light of the COVID-19 pandemic, access to the in-person meetings will be restricted to one delegate per Member State and one delegate each from the Holy See, the State of Palestine, and the European Union. Additional information on precautionary measures aimed at mitigating the spread of COVID-19 will be circulated in advance of the session.

The proceedings of the meeting will be webcast live and on-demand on UN Web TV.

The virtual informal meetings will take place using the remote simultaneous interpretation platform "Interprefy".
