

## **Strategic Needs Fellowship**

### **Training curriculum**

*Note:* The following general training curriculum outlines the core sessions and professional skills development activities; however, it is not exhaustive and is adapted to address the specific needs identified by the Fellows in their applications. Intergovernmental meetings at UNHQ that will be observed by the Fellows will depend on their scheduling.

Sessions are mainly delivered by DOALOS staff and other United Nations staff including from UN System Organizations, as well as external experts and practitioners, primarily affiliated with academic [Host Institutions](#) of the United Nations-Nippon Foundation (UNNF) Programmes and Alumni of the UNNF Programmes.

The sessions are conducted in various formats, including lectures, group exercises, and workshops.

The Strategic Needs Fellowship runs in parallel with the [Ocean Governance Fellowship for Small Island Developing States](#) (SIDS). Nationals from SIDS participating in the Strategic Needs Fellowship will also have the opportunity to join sessions, group discussions, and activities focused on addressing the specific perspectives, challenges, and opportunities faced by SIDS.

Fellows will have the opportunity to observe intergovernmental meetings and other multilateral processes related to ocean affairs and the law of the sea at United Nations Headquarters, actively engaging in discussions and completing assignments related to these events.

### **IV. Fellowship deliverables**

Successful completion of the programme requires the submission of the following deliverables, which may include:

- a. A research paper and/or an ocean governance matrix addressing the specific needs as outlined in the Fellow's application and supported by the Nominating Authority.
- b. An oral presentation of the research paper and/or ocean governance matrix findings to the group, followed by an interactive Q&A session.
