SESSION 5: FINANCING FOR SUSTAINABLE TOURISM DEVELOPMENT

Background

A lack of financing for tourism still hinders tourism to fully unfold its potential as a key instrument for sustainable development, green growth and poverty reduction. The sector is still underrepresented in aid flows as only 0.09% of total ODA and 0.78% of total Aid for Trade (AfT) disbursements were directed to tourism in 2013.

Most SIDS share a number of key challenges related to financing for development which directly impact their capacity for sustainable tourism. Challenges include limited capacities to mobilize domestic resources, high per capita costs for essential service provisions and vulnerability to environmental and economic shocks. Climate adaptation costs are also among the highest in the world for SIDS when measured as a proportion of national output. Overall, high levels of public debt remain a key challenge for many small island states.

The horizontal nature of the sector and its many linkages to other activities along the value chain requires that the international community develops an approach to tourism financing that promotes cross-sector cooperation and solutions (Medellín, Colombia, 15 September 2015).

Key objectives:

- 1. Share country experiences and exchange of views on how financing for tourism development can improve the tourism sector and complement the 2030 Agenda, the SDGs and the SAMOA Pathway.
- 2. Explore how policy, legal and institutional frameworks can help integrate financing for tourism sustainable tourism in SIDS.
- 3. Explore the contribution of financing to promote responsible, responsible, resilient and sustainable tourism, inclusive of all peoples.
- 4. Explore enabling conditions that can enhance public and private sector investments including ODA
- 5. Identify successful public-private sector partnerships for improving financing for Tourism and examine how these can be scaled in other SIDS and regions.
- 6. Announcement of new partnerships related financing of sustainable development that can help unlock the potential of sustainable tourism in SIDS and support the achievement of the SDGs.
