## **Excellencies, Ladies and Gentlemen**

Mr. Chairperson, our Group has made significant strides under your able leadership assumed at the beginning of this year. My delegation remains confident that you will lead us to the successful execution of the work of our Group. As a current member of the Bureau of the LLDCS, we assure you of our unwavering support throughout your tenure of office.

Congratulations Excellency, Ms. Rabab Fatima for your well-deserved appointment as the High Representative for the Least Developed Countries, Landlocked Developing Countries and Small Island Developing States. Madam Under Secretary General, we stand ready to offer you our unconditional support especially as you lead us in the next programme of action.

## **Excellencies**

On top of a myriad of challenges hampering development in LLDCs, related to our landlockedness, the lack of access to the sea and global markets, Covid-19 has exacerbated the dire situation we are in and has thus reversed gains made in meeting the priorities of the Vienna Programme of action (VPoA) for LLDCs. This situation is even worse in LLDCs which are also LDCs and located in Africa as they are the hardest hit owing to the fragility of our health systems and limited social support and protection measures as well as lack of financial resources to address all these challenges. In this connection, Mr. Chairperson, we find this year's theme both timely and appropriate.

The recent Secretary General's Report on the implementation of the VPoA reveals that the rising energy and food prices, supply chain disruptions and elevated shipping and trade costs are an impediment to LLDCs to recover from the socioeconomic impacts of COVID- 19 pandemic. This indeed rings an alarm bell that unless there is enhanced international support towards recovery, it will be difficult for us to realise the implementation of the VPoA and other development agendas.

### **Mr. Chairperson**

With just two years left before the end of the VPoA, **NOW** is the time to act! It is not too late for our Group to start to make concerted efforts aimed at fostering renewed and strengthened partnerships for the full and timely implementation of the VPOA as well as building back better in recovering from Covid-19. We are encouraged to learn that the Office of the High Representative and that of the Chairperson are considering to bring to life the Group of Friends of LLDCs which would be helpful in the acceleration of VPoA.

### **Mr. Chairperson**

The United Nations System remains one of our strongest pillars in supporting the implementation of the VPoA as well as the 2030 Agenda for Sustainable Development. Again, their commitment in addressing the adverse impacts of Covid-19 in our respective countries cannot be over emphasised. In this spirit, we call on them to further accelerate the implementation of the well calibrated Roadmap we adopted exactly two years ago.

## **Mr. Chairperson**

As the time for the Third United Nations Conference on LLDCs is fast approaching, Lesotho remains committed to be involved meaningfully in all the preparatory stages that will lead to the successful outcomes of the conference in 2024. Furthermore, we look forward to a renewed framework for international support including developed states, transit countries and development partners that will address our recovery from Covid 19, rising inflation, food insecurity, adverse impacts of climate change and all other trade and transit related vulnerabilities that endanger our development prospects.

Finally, Mr. Chairperson, it is incumbent upon us to ensure that the OHRLLS is capacitated. To this end, Lesotho wishes to reiterate the call for the strengthening of the OHRLLS to provide the required support to LLDCS in its quest to implement the Vienna Programme of Action and the new programme of Action for LLDCs in 2024. This in as much as it has similar responsibilities in upgrading LDCs and SIDS, this all countries in special situations that need not be left behind.
