Workshop on the trade elements of the Doha Programme of Action for LDCs (DPoA)

27-28 May 2025, Bangkok, Thailand

The Doha Programme of Action for the Least Developed Countries for the Decade 2022-2031 (DPoA) provides a framework to address key challenges faced by LDCs to achieve sustainable development. Trade features prominently in the DPoA, as evidenced through one of its six key focus areas aimed at enhancing international trade and the regional integration of LDCs.

The Doha Programme of Action for LDCs, with its emphasis on enhancing international trade and regional integration, highlights the potential of digital trade to level the playing field for LDCs. As the world becomes increasingly interconnected, e-commerce presents a pivotal opportunity for these countries to leapfrog traditional trade barriers and integrate into global markets. By developing robust e-commerce ecosystems, LDCs can reduce trade costs, enhance access to global consumers, and foster economic growth. This is particularly crucial in the Asia-Pacific region, where UNESCAP's initiatives can support LDCs in leveraging digital platforms to boost exports and diversify their economies. However, challenges such as market power held by global platforms and the need for improved ICT infrastructure must be addressed. By focusing on e-commerce development within the DPoA framework, LDCs can harness the power of digital trade to accelerate their economic transformation and achieve sustainable development goals.

On the sidelines of UNESCAP's Committee on Trade, Investment, Enterprise and Business Innovation, the Workshop on the DPoA aims to take stock of key trade-related elements of the DPoA and provide an opportunity for LDCs in the Asia-Pacific region to share their experiences. The Workshop will also allow the participants to attend the trade sessions under the aegis of UNESCAP's Committee on Trade, Investment, Enterprise and Business Innovation with a view to furthering the trade-related objectives of the DPoA.

Session 1: LDC Graduation in Asia and the Pacific and trade elements of the Doha Programme of Action

This session will examine the status of LDC graduation in Asia and the Pacific and highlights the important role of trade for graduating countries. It will take stock of the progress in implementing the trade-related targets of the Doha Programme of Action. In particular, it will examine the longstanding LDC priorities including structural transformation, Duty-free Quota-free market access to LDCs, preferential rules of origin, the LDC services waiver, and trade facilitation. The discussion will explore strategies for graduating countries to maintain their trade competitiveness including through structural transformation, preferential market access, simplified rules of origin, and enhanced trade facilitation, while leveraging the services waiver to expand services trade. Additionally, the session will address TRIPS and IP regime issues, considering the potential challenges graduating LDCs may face in adapting to full compliance with intellectual property rights obligations. By addressing these critical trade elements, the session aims to provide insights into how the DPoA can support LDCs in navigating graduation challenges and maximizing their trade potential.

Session 2: Trade opportunities for graduating LDCs
