

## **AIR TRANSPORT IMPACT**





Under Air Transport, It is projected that African airports will experience revenue loss of 60 % for the year 2021 due to restrictions introduced on aviation activities, with the loss estimated at USD 2.2 billion as per analysis released by Airports Council International (ACI).

Revenue losses are currently estimated to be over USD \$10 billion for African airlines according to data from IATA as at end of August 2021.

Furthermore, cash liquidity challenges and fluctuations in foreign currencies will result in job losses for the Civil Aviation Authorities (CAAs), Airports, Air Navigation Services Providers (ANSPs) and other strategic institutions and pillars that drive air transport's contributions to the African economy.

#### LAND AND MARITIME TRANSPORT IMPACT

#### **Maritime Transport**

Direct negative impact on port traffic

Negative impacts on shipping industries and economies

Negative impact in supply chain and logistics due to closure of port activities

Negative impacts on African States economic performance due to an important disruption in supply chain especially on cross border trade

# Land Transport (Road, Railway and Public Transport)

Closure of borders between various African countries in order to stop the cross border movements that would cause the rapid spread of the pandemic

Disruption of the supply chain for essential commodities (agricultural products, medical supplies and equipment) transported along the important corridors and across the borders and this has affected the intra African trade and tourism.

The first global figures indicated that travels have dropped by 40%, more passengers than freight, as some governments have sometimes guaranteed food market provision. Public transit usage has dropped even more (over 60% in many cases).

There are also impacts related to road and rail investments. While revenue from road tolls seriously declines, as a result of a significant drop in traffic, concessionaires and governments benefiting from PPP-funded routes may face challenges in reimbursing the borrowings on time.

# Land and maritime transport sectors impact





Closure of borders between various African countries in order to stop the cross border movements that would cause the rapid spread of the pandemic



The port sector have been impacted by the Covid19 pandemic, with significant disruptions to shipping and maritime transport



Since the beginning of the crisis, about 30% of the maritime sector was adversely affected but it is important to emphasize the resilience of the port and Maritime industry to withstand total collapse and devastation

### Challenges

Risks of job losses in Transport services( Ports, Airports, Air Navigation Services, public transport services ,etc...)

Closures of airspace and airports, borders and restrictive procedures for cargo flights and humanitarian assistance



# Mitigation & Resilience Immediate

Financial support to maintain jobs in transport
Implementation of proposed short-term relief
measures to ensure continuity of transport
services

Ensure all AU States adopt uniform and harmonized Emergency Response Measures to keep the supply chains open, facilitate landing permits for cargo flights, manage crews harmoniously and adopt stepped-up security screening measures as communicated by Africa CDC and WHO



# Medium-Long term interventions

**Develop Supply Chain Resilience Strategy** 

Implementation of medium to long term relief measures to assist transport companies recover from the impacts of COVID-19 ( airlines, airports operators, ports authorities, public transport companies, tourism firms, hotels, etc..)

Increased advocacy for political will to implement the comprehensive Post-COVID-19

## Short term

Support for continuity of critical cargo flights and shipping industry and services

Facilitate opening airspaces and airports State assistance to airlines, airports and Air Navigation Services Providers (ANSPs);

Establish a comprehensive post-COVID National Civil Aviation Recovery Plans



# Medium Term

Provide expertise, coordination and technical assistance to support Member States.

Prevent disruption during pandemic crisis.

Establish a platform to share policy and regulatory experiences and best practices that can improve COVID responses.



# Long Term

Engaging the Development partners to mobilize the required continental stimulus package estimated at USD 18 Billion to support the recovery of the African civil aviation sector.

AUC in collaboration with Africa CDC launched "Saving lives, saving economies and livelihoods" campaign with the main objectives to harmonize the public health measures and support a safe and secure reopening of borders.

Established High Level Task force to coordinate comprehensive continental strategy
