# Draft Term of References For LLDCs NFPN

## National Institution set-up

*VPoA Para 74 LLDCs and transit developing countries are encouraged to establish national coordination mechanisms, where appropriate.*

## Promote mainstreaming of the Programme of Action

## Building coherence

*With regional and global frameworks, including the the 2030 Agenda for Sustainable Development, and other global frameworks*

## Country level coordination

*Coordination at national level including on preparing of reports on the implementation of the VPoA and other relevant documents*

## Promote national awareness

*Ensuring that VPoA is known and understood by relevant agencies of government, academia and other relevant stakeholders.*

## Keep abreast of opportunities for support and mobilize support

*support by development partners, including the UN system, and identify potential areas for increased donor collaboration and coordination in supporting the implementation of the VPoA, the 2030 Agenda, the SDGs and other global frameworks*

## Participate in a forum for LLDCs NFPs

## Monitoring and reporting

*Contribute to coherent national, regional and global monitoring of the VPoA, the 2030 Agenda for Sustainable Development, SDGS and other global frameworks.*



# Preparation for the Third UN Conference on LLDCs: the role of NFPs



- Coordinate national level preparation:
  - Preparation of national report on the review of the VPoA
  - Coordination with all relevant stakeholder including DCO and the relevant ministries and private sector
- Participate in the regional preparatory meetings and other relevant thematic events
- Review reports and make substantive inputs
- Coordinate with the New York based focal point and provide substantive support to the outcome document
- Advocate for high-level participation at Third UN Conference on LLDCs in 2024
