At the AFICS/NY Governing Board meeting on 13 September, the Governing Board elected the following Bureau:

## Bureau

President: Deborah Landey. Deborah served in the UN system for 35 years, in UNDP, UNAIDS and UNDOCO, including as a United Nations Resident Coordinator, Deputy Assistant Administrator for Management of UNDP, Deputy Executive Director of UNAIDS and Director of UNDOCO. She has served as the First Vice-President of AFICS/NY Governing Board since 2014, and as a FAFICS Vice-President for the past couple of years. She was just re-elected to serve a further two years in that capacity.

First Vice-President: Darshak Shah. Darshak served as Senior Advisor to the Administrator, Deputy Assistant Administrator, Bureau for Management Services and the Global Chief Finance Officer (CFO) of UNDP. For many years he Co-Chaired the HLCM/Finance and Budgetary Network and chaired many UNDG Task Forces on a range of UN reform issues. He worked extensively with governing bodies such as the Fifth Committee, Executive Board of UNDP, Joint Boards and ACABQ. He has also worked with oversight and other committees like the HLCM and Audit Committee of UNDP, JIU. He has extensive experience in working with member states. He has served as the Second Vice-President of the AFICS/NY Governing Board since September 2021.

Second Vice-President: Nancy Hurtz-Soyka. Nancy worked in the UN for over 35 years in various management roles including the UN Budget Division, Chief of the Office of Under-Secretary-General for Management, Head of the Ethics Office, as well as Chief of the Accountability and Oversight Office. She has served on the AFICS/NY Governing Board Committee on Health and Life Insurance since 2020 and was Co-Chair with Sudershan Narula of the Nominating Committee in 2021. She has served as the Rapporteur for the FAFICS Council since July 2021 and for the FAFICS Bureau since January 2022.

Treasurer: Mac Chiulli. Mac worked for the UN for 15 years after 25 years in the private sector, serving in the Accounts Division, and as Executive Officer of DGACM. She also served on the HQ Committee on Contracts (HLCC), the G-to-P and National Competitive Exam Boards (JPP), the Capital Master Plan project, and the Supervisory Committee of the UNFCU. She joined AFICS/NY in 2014 and has served as the AFICS/NY Treasurer since 2020, and has been the Chair or Co-Chair of the AFICS/NY Governing Board Ageing Smart and IT Committees for 4 years.

Secretary: Susan de Souza. Susan worked in the UN for over 35 years in multiple duty stations and Peacekeeping Missions. She has served as the AFICS/NY Governing Board Secretary since 2021. She has served as the Co-Chair of the AFICS/NY Governing Board Social and other Events Committee since 2017 and has also set up and runs an AFICS/NY virtual Book Club.

Deputy Secretary: Marianne Brzak-Metzler. Marianne worked for the UN for 28 years in various management positions both in the Office of Financial Services and in the Office of Human Resources Management (OHRM). Marianne served as Chief, Conditions of Service Section and was responsible for managing the compensation programme of the United Nations and other conditions of service of locally recruited staff at some 160 duty stations as well as internationally recruited staff at Headquarters. She carried out surveys and prepared position

papers and reports on the conditions of service of officials such as the Secretary-General, the Deputy Secretary-General, the Administrator of UNDP, the two full-time members of the International Civil Service Commission (ICSC), the Chairman of the Advisory Committee on Administrative and Budgetary Questions (ACABQ), the Members of the International Court of Justice, the Judges and Ad-Litem Judges of the International Criminal Tribunal for the Former Yugoslavia (ICTY) and the International Criminal Tribunal for Rwanda (ICTR). After serving as the Secretary of the AFICS/NY Governing Board for several years, since 2021 Marianne has been the Deputy Secretary. She was also a member of the AFICS/NY Governing Board Nominating Committee in 2022.
