SITUATION REPORT for NY, NJ, CT, PA and DC 04 June 2021

GENERAL SITUATION

The <u>Centers for Disease Control and Prevention</u> updated its guidelines regarding Covid-19 travel restrictions state by state and International Travel During COVID-19.

<u>Vaccine mega-sites starting to close in Tri-State</u>: Signs continue across the Tri-State region that things are moving in the right direction amid efforts to end the pandemic. In New York City, <u>the vaccination mega-site at the Javits Center will close</u> to make way for the auto show. Mega-site shutdowns are starting even sooner in New Jersey, starting with the Meadowlands today.

<u>New York:</u> A new pop-up vaccination site is opening Friday at Belmont Park on Long Island. Those who get vaccinated at the park <u>will receive general admission tickets to next year's running of the Belmont Stakes</u>.

New Jersey Governor Phil Murphy signed a legislation today enabling the end of the COVID-19 Public Health Emergency that has been in place since March 9, 2020. Immediately following the signing of the legislation, Governor Murphy signed Executive Order No. 244, ending the COVID-19 Public Health Emergency. Under the legislation, the majority of executive orders issued pursuant to the Public Health Emergency will expire 30 days from Friday.

<u>New Jersey:</u> N.J.'s COVID indoor gathering limits end today including large concert, sports venues. <u>Here are the details</u>.

<u>Washington D.C.</u>: certain D.C. public schools will offer COVID-19 shots to residents age 12 and older. Walk-up clinics will be available at Anacostia High School, Eastern High School, Luke C. Moore High School and Ida B. Wells Middle School. No appointments are needed. <u>Here's information on operating hours</u>.

Washington D.C.: Most businesses in D.C. are operating without any restrictions. Restaurants, wedding venues, places of worship, retail stores and gyms may all operate at 100% capacity, with no social distancing requirements. But a few businesses will have to wait a little longer. Large sporting venues, bars and nightclubs, and music and entertainment venues won't be able to open at full capacity until June 11.

NEW YORK STATE

The Tribeca Film Festival is set to open June 9th at the Pier 76 Park with a showing of Lin Manuel Miranda's "In The Heights". Closing night will feature a red-carpet performance on June 19th at Radio City Music Hall at full capacity, with a 100% vaccinated, mask-free audience.
