## Written submissions to the Peacebuilding Commission's Ministerial Meeting

### FANCV INPUT:

We are faced to an antagonistic dichotomy: On one hand we have the urgent need to **REDEFINE** and give superlative importance to the **"SOCIAL, ETHIC, AND MORAL RESPONSIBILITY OF STATES TO PROTECT THEIR POPULATION"** and, on the other hand, the **lack of "Respect for the Right to Life"**, fundamental essence of a purely humanist vision, such as the Protection of Human Rights.

They turn out to be two truths and an antagonistic dichotomy, because while the **"Responsibility of States to Protect"** has the purpose of the **"Respect for Human Rights"**, are the States that, for the sake of fulfilling the ideological vision of the ruler in power, the first thing that is limited is the manifestation of the breadth of the Human Rights' Protection.

Diversity of UN Resolutions conspire against Peacekeeping, not only due to the influence of the diversity of current ideologies, but also due to corporate selfishness **whose arguments undermine the strong ideas that made of the Spirit of the UN Charter the "sublime Protection of Hope" that all the people of the world claim today**, (including Biodiversity, whose impact irremediably contributes to the imbalance of Climate Change and its nefarious consequences).

For this reason, we invite everyone who yearns to live in a **Better World to join the Creative Spirit of the UN Charter**, after the horrors of World War II.

### **TRUST – SOLIDARITY – UNIVERSALITY.**

It is NOT the prevailing value's systems that destroy Universality, but the LACK of Understanding of the profound meaning of Understanding that our Rights END where our neighbor's rights BEGIN, and their Rights end where our Rights begin.

**FANCV suggests:** Create a Subcommittee or a Sub-axis, within the Peacebuilding Commission, in charge of regulating projects on the diversity of existing and future Mental Control Technologies, as well as Robotic Technology, in the broad spectrum of human activities, (and their application from the space combat methodologies), taking into account the effects of their implication in Peacekeeping. **THE REGULATION OF RESOLUTIONS THAT DELIMIT ITS ACTION IS URGENT, BASED ON THE ETHICS OF THE PROTECTION OF PRESENT AND FUTURE HUMAN RIGHTS, THE ENVIRONMENT AND BIODIVERSITY.**
