1. Denmark's Foreign Minister reaffirmed strong political and financial commitment and announced plans for a new financial increase in Denmark's multiannual contribution. The 2021 pledge is yet to be confirmed.

2022

2. Japan's State Minister for Foreign Affairs announced a contribution of USD 10 million for the period of the Fund's 2020-2024 Strategy. The annual breakdown is yet to be confirmed.

3. The Minister of State stressed the UK continues to support increasing the resources of the Fund through new voluntary funding. The confirmation of the UK's new contribution amount is still pending.

4. Finland's Foreign Minister highlighted the country's committment to remain a close partner and contributor to the Fund. The 2021 pledging amount is yet to be confirmed.

5. The Deputy Minister for Global Affairs of the Republic of Korea reaffirmed the Governmet's full support to the PBF 2020-2024 Stratey and underlined the commitment of scaling up contributions to the Fund in the coming years. The 2021 pledging amount is yet to be confirmed. 6. Poland's Foreign Minister stressed that the Government remains fully committed to support the Fund politically and financially. New pledges are yet to be confirmed.
