

The Government of the Republic of Moldova has the honour to nominate Ambassador Natalia Gherman for the post of the Secretary-General of the United Nations. Ms. Natalia Gherman is a prominent diplomat whose leadership and merits are recognized and appreciated in her own country and internationally. Her curriculum vitae is attached hereto (see enclosure).

Ambassador Gherman held various top positions in the Government of the Republic of Moldova, including Deputy Prime-Minister and Minister of Foreign Affairs and European Integration, Acting Prime-Minister as well as Member of the Parliament of the Republic of Moldova. She represented her country with dignity as Ambassador to the UN Agencies in Vienna, to the Organization for Security and Cooperation in Europe, to the Republic of Austria, the Kingdom of Sweden, the Kingdom of Norway and the Republic of Finland.

The recognition of the authority of Ms. Gherman was best displayed in her leadership of the United Nations Global Dialogue on Institutional Capacities for Sustainable Development and their indicators, and subsequent adoption of the Chisinau Outcome Statement, that proved to be a valuable contribution to the new global development roadmap for the next fifteen years. Coordinating the national efforts to deliver on Post-2015 Development Agenda, Ms. Gherman focused on strengthening the human rights mechanisms, women empowerment and gender equality, as well as promotion of Moldova-UN cooperation in the field of energy. Moreover, Ms. Gherman was an efficient partner for the United Nations in Moldova and in the region, for a successful piloting of one of the aspects of the UN reform - the concept of One UN.



H.E. Ms. Natalia Gherman

Ms. Natalia Gherman has served for the past three years as Deputy Prime-Minister and Minister of Foreign Affairs and European Integration of the Republic of Moldova. In June-July 2015 she was Acting Prime-Minister of the Republic of Moldova. Ms. Gherman is a career diplomat holding the diplomatic rank of Ambassador. Her leadership qualities and excellent negotiation skills are highly appreciated in her own country and internationally.

Ms. Natalia Gherman received her BA from the State University of the Republic of Moldova and her MA in War Studies from King's College, University of London.

Ms. Gherman began her long career in service of her country in 1991 as the Second and then First Secretary for the Department of International Organizations of the Ministry of Foreign Affairs of the Republic of Moldova. From 1994-7, she served as Counsellor and Deputy Permanent Representative to the UN Agencies in Vienna and the Organization for Security and Cooperation in Europe (OSCE). From 1997-2001, Ms. Gherman became the Deputy Head of the Department of European Security and Political-Military Affairs of the Ministry of Foreign Affairs. She served as Minister-Counsellor of the Embassy of the Republic of Moldova in Brussels as well as Deputy Head of the Mission of Moldova to NATO from 2001-2.

This led to Ambassadorships, first as Ambassador to the Republic of Austria and Permanent Representative to the UN Agencies in Vienna and to the OSCE. Representing her country with dignity to the OSCE in Vienna, Ms. Gherman has been a prominent contributor to the efforts of the Organization in identifying solutions to the unresolved conflicts in the OSCE area, at the same time mobilizing the potential of the OSCE community towards the settlement of the Transnistrian conflict in the Republic of Moldova in accordance with the provisions of International Law. She is an expert and leader in regional and global security affairs, promoting peace through dialogue, justice, sustainable development and deep respect for the rule of law.

From 2006-9, Ambassador Gherman established the diplomatic presence of her country in the Nordic region, having served as first resident Moldovan Ambassador to the Kingdom of Sweden, the Kingdom of Norway and the Republic of Finland. For her merits in promoting relations between Sweden and Moldova, His Majesty the King of Sweden awarded Ms. Gherman the Royal Order of the Polar Star of the Kingdom of Sweden in the rank of Commander First Class.

As Deputy Minister of Foreign Affairs and European Integration in 2009-13, Ms. Gherman was the Chief Negotiator on behalf of the Republic of Moldova for the Association Agreement and Deep and Comprehensive Free Trade Area with the European Union. Ambassador Gherman has also successfully led the EU-Moldova visa dialogue that resulted in liberalization of the visa regime for Moldovan citizens travelling to the EU. These remarkable achievements placed Moldova on the path of reforms to further develop the standards of democracy, security, the rule of law and economic modernization. For the successful negotiation of these crucial Agreements, in 2014 Ms. Gherman was awarded the highest national distinction - the Order of the Republic of Moldova.

In 2013, Ms. Gherman was honoured with dual role of Deputy Prime-Minister and Minister of Foreign Affairs and European Integration. As Deputy Prime-Minister, her role was to coordinate the European Integration process of the Republic of Moldova, including by the implementation of the EU-Moldova agreements. Another major responsibility of Ms. Gherman was to chair the National Committee for Combating Trafficking in Human Beings, where she pressed for enhanced international cooperation in investigating trafficking cases and for legal reforms to strengthen the protection of victims, in particular children.

Ms. Natalia Gherman has played a central role in adapting the migration policy of the Republic of Moldova to the needs of sustainable development of the country. She was coordinating the implementation of the pilot EU-Moldova Mobility Partnership and actively participated in the activity of the Global Forum for Migration and Development. Under her leadership, Moldova contributed to the High-Level Dialogue on International Migration and Development, advocating for the integration of migration into the Post-2015 UN Agenda.

She was elected as Member of the Parliament in 2014 and served as member of the Parliamentary Committee on Foreign Policy and European Integration until the new Government was formed in 2015, where she resumed her role as Deputy Prime-Minister and Minister of Foreign Affairs and European Integration. In June-July 2015, Ms. Gherman was the Acting Prime-Minister of the Republic of Moldova.

The affirmative legacy of Ms. Gherman's authority on a global scale were best reflected in her leadership of the UN Global Dialogue on Institutional Capacities for Sustainable Development and their indicators, and subsequent adoption of the Chisinau Outcome Statement that provided a valuable input to the adoption of the Sustainable Development Goals. While coordinating the national efforts to deliver on Post-2015 Development Agenda, Ms. Gherman focused on strengthening the human rights mechanisms, women empowerment and consolidation of Moldova-UN cooperation in the field of energy.

From 2009 onwards, Ms. Gherman coordinated a wide range of projects implemented with the assistance of the UN in Moldova, among them the institutional capacity building as part of the reform of the public administration, confidence building measures for the population in the areas affected by the unresolved conflict, promoting a higher representation of women at the decision making level. Ms. Gherman's involvement has been instrumental both in Moldova and in the region, for ensuring efficiency in piloting of one of the aspects of the UN reform - the concept of One UN.

In 2014 Ms. Natalia Gherman was selected by The Guardian UK to rank among the most impressive "Seven women to watch in global politics who are leading change all over the world".

She is mother to son Mircea Gherman and the daughter of Mr. Mircea Snegur, the first President of the Republic of Moldova.
