Excellency,

In our capacity as the Co-Chairs of the intergovernmental negotiations on Security Council Reform, we write to inform you of the details of the first meeting to be held in the framework of the intergovernmental negotiations. We wish to update Member States that the meeting has been rescheduled to be held on 1-2 February 2018 in the Trusteeship Council Chamber, instead of the 29 - 30 January date previously communicated in our letter dated 11 December 2017.

After having consulted widely with the Member States, the Co-Chairs invite the membership to reflect on the activities of the intergovernmental negotiations, including the documents referred to in the oral decision 71/553 adopted by the General Assembly on July 19, 2017. Such a retrospective exercise will provide the membership with an opportunity to build on the cooperative work of Member States and to highlight both the achievements and ways to further strengthen and develop the intergovernmental negotiations. Member States are encouraged to comment on, and identify any perceived gaps in the previous documents including any potential elements of convergence that have not yet been, or can be further, explored. The Co-Chairs invite the membership to engage in a frank dialogue on the assessment of the intergovernmental negotiations, and to offer feedback and specific proposals on how to move forward on any of the five clusters in the current session. We invite member states to tailor their interventions to be as specific as possible, in order to allow for an interactive exchange of views.

We further wish to take this opportunity to inform you of the dates of upcoming meetings scheduled for the 2018 session of the intergovernmental negotiations:

- 27 28 February 2018, Conference Room 2;
- 27 28 March 2018, Trusteeship Council;
- 1 2 May 2018, Trusteeship Council;
- 6 7 June 2018, Conference Room 1.

We look forward to the active participation of delegations in the forthcoming meetings of the intergovernmental negotiations. The Co-Chairs remain available for consultations throughout the negotiations.
