## 2030 Agenda Alignment on ECOSOC and the GA

Thursday 3<sup>rd</sup> May 2018

- How can we ensure that the General Assembly Committees, the ECOSOC and their subsidiary bodies, the HLPF and other related forums, address the 2030 Agenda for Sustainable Development in an integrated and coherent manner?
- How can the General Assembly Committees coherently incorporate into their agendas, the 2030 Agenda and its SDGs?
- How can we distinguish necessary overlap (e.g. in cases where ECOSOC follows-up on the implementation of GA policy guidance, such as on UN operational activities for development, or in cases where the same issue is addressed from different perspectives) from unnecessary overlap?
- Where do you see the greatest overlaps and the greatest potential synergies between the agendas of those various bodies?
- How can the consultations take into consideration other related processes, such as revitalization of the General Assembly, the review of General Assembly resolution 68/1 on the strengthening of ECOSOC, and the repositioning of the UN development system?
