CONCEPT NOTE

Third High-level Meeting of the General Assembly on the Prevention and Control of Non-Communicable Diseases (New York, 27 September 2018)

Context

- In accordance with resolution 72/274 on the “Scope, modalities, format and organization of the third High-level Meeting of the General Assembly on the prevention and control of non-communicable diseases” (NCDs), the President of the General Assembly will convene a one-day high-level meeting on **27 September 2018** in New York to undertake a comprehensive review of the prevention and control of NCDs.
- The **theme** of the third High-level Meeting on NCDs is “Strengthening health systems and financing for the prevention and control of NCDs, on each country’s path towards achieving UHC, including through sharing evidence-based best practices, scientific knowledge and lessons learned”.
- The third High-level Meeting on NCDs will provide Member States and other stakeholders with an opportunity to contribute to the appraisal of the **progress** achieved in implementing the commitments made at the UN General Assembly high-level meetings in 2011, 2014 and the progress to achieve the relevant SDG targets of the 2030 Agenda for Sustainable Development, including the target to reduce by one third premature mortality from NCDs through prevention and treatment.
- The High-level Meeting shall approve a Political Declaration on the prevention and control of NCDs.
- The meeting will comprise of an opening segment, a plenary, two consecutive interactive multi-stakeholder panels held in parallel to the plenary, and a closing segment.

Multi-stakeholder Panel 1

Background

- Multi-stakeholder Panel 1 will address the theme “Strengthening health systems and financing for the prevention and control of NCDs, on each country’s path towards achieving universal health coverage, including through sharing evidence-based best practices, scientific knowledge and lessons learned”. Participants will include representatives from Member States, observers, UN entities, civil society, philanthropic foundations, academia, medical associations, the private sector and broader communities.
- Panel 1 will highlight challenges and successes at the national and subnational levels to scale up action to prevent and control NCDs.

Guiding questions

- 1) How can governments ensure that national UHC packages include NCD and mental health services? Examples from countries that have done this successfully?
- 2) What specific steps can countries take to make sure NCDs prevention and control are firmly embedded in primary healthcare?
- 3) What options are available for international financing for NCDs?
- 4) What are the lessons learned from countries that have developed and implemented fiscal policies to finance NCD responses?

Format

- The Panel will be chaired by two high-level representatives of Member States. Following a short introduction by the co-chairs, panellists will deliver their remarks.
- The floor will then be opened for interventions from Member States and other participants. Speakers should limit their interventions to two minutes each.

Outcome

- The outcome will be a summary of the discussions to be presented during the closing segment.

- The floor will then be opened for interventions from Member States and other participants.

- The outcome will be a summary of the discussions to be presented during the closing segment.
