¹ As indicated in paragraphs 23 and 24 of report A/73/203, upon receipt of the completed written examinations from the shortlisted candidates, the Office of Administration of Justice eliminated all identifying elements in the examinations before transmitting them to the Council for its review and marking. Accordingly, no Council member knew the name, nationality, gender or other identifying information about the candidates when assessing their examinations. To successfully pass the written examination and be selected for the interview, candidates had to display in their written assessments the writing skills and strength of legal analysis necessary for them to serve as excellent judges on the Tribunals. On the basis of the written assessment, the Council selected a total of 16 applicants for the interview.
