We are pleased to write to you in our capacity as co-facilitators appointed by the President of the General Assembly to oversee the preparatory process and to conclude the intergovernmental consultations on the declaration for 2020 United Nations Conference to support the implementation of Sustainable Development Goal 14.

It is our pleasure to share with you the updated programme for the Preparatory Meeting, which will take place 4-5 February 2020 in United Nations Headquarters Conference Room 4. The purpose of the Preparatory Meeting is to consider the themes for the interactive dialogues and elements of an intergovernmentally agreed declaration. As mandated in General Assembly resolution 73/292, the declaration shall be brief, concise and action-oriented and focus on, and highlight, the science-based and innovative areas of action to support the implementation of Sustainable Development Goal 14.

We invite Member States to make separate statements on the themes of the interactive dialogues and on the elements of the declaration. In order to ensure that we will have a focused and fruitful discussion at the Preparatory Meeting, we encourage you to address the guiding questions that we circulated in our previous letter, dated January 22 2020.

There is no established list of speakers for the Preparatory Meeting. The time limits for statements will be five minutes for statements delivered on behalf of a group of States, three minutes for individual delegations and two minutes for observers and stakeholders. We will kindly ask all delegations to adhere to these time limits. All delegations are encouraged to submit the full-length version of their statement to the Secretariat [email. chatterjeem@un.org] for posting on the Conference website.

We are committed to an open, inclusive, transparent process, and count on your support and your active and constructive engagement. We stand available to meet with Member States throughout the process, and encourage you to reach out to us at your convenience.
