Excellency,

I have the honour to refer to my letter dated 3 May 2021 regarding the Special Session of the General Assembly on Challenges and Measures to Prevent and Combat Corruption and Strengthen International Cooperation, to be held from 2 to 4 June 2021 at United Nations Headquarters in New York, pursuant to General Assembly resolutions 73/191 and 74/276, as well as decisions 74/568 and 75/562 entitled "Special session of the General Assembly against corruption".

In this regard, I would like to inform you that, pursuant to General Assembly resolution 74/276, **a draft political declaration**, agreed upon in advance by consensus through intergovernmental negotiations under the auspices of the Conference of States parties to the United Nations Convention against Corruption, will be issued as A/S-32/L.1. As indicated in the provisional program of the session, I propose the adoption of the political declaration by the General Assembly at the opening segment of the Special Session.

I have the further honour to circulate, as an annex to this letter, a provisional list of speakers for the plenary meeting of the Special Session as of 21 May 2021. An updated list of speakers will be circulated by the Secretariat prior to the start of the Special Session.

In line with paragraph 2 (c) of General Assembly resolution 74/276, I intend to invite the following **representatives from relevant organizations attending the Special Session to make statements at the plenary meeting**, time permitting:

- Mr. Ahmad Bin Abdulla Bin Zaid AL Mahmoud, Chair of Global Organization of Parliamentarians Against Corruption;

All Permanent Representatives and Permanent Observers to the United Nations New York In addition, if I hear no objection by 5 p.m. on Friday, 28 May 2021, I intend to invite Mr. Maurice Nyambe, Executive Director of Transparency International Zambia and Ms. Cynthia Gabriel, Founder and Executive Director of Center to Combat Corruption and Cronyism, to make a statement at the plenary meeting as representatives from non-governmental organizations that are not in consultative status with the Economic and Social Council, in accordance with the General Assembly resolution 74/276 and its operative paragraph 2 (c).

Pursuant to paragraph 17 of General Assembly resolution 74/276, I intend to invite Ms. Serena Ibrahim, Founder of Youth against Corruption as a **youth representative** to deliver, at the opening segment of the Special Session, a statement on the outcome of the discussions at the youth forum organized virtually by the UNODC, on 24-26 May 2021.
