We are writing to you in our capacity as co-facilitators of the intergovernmental negotiations related to General Assembly resolutions 74/298 on the review of the implementation of General Assembly resolution 67/290 on the high-level political forum on sustainable development, 70/299 on the follow-up and review of the 2030 Agenda for Sustainable Development at the global level and 72/305 on the strengthening of the Economic and Social Council.

We refer to our letter of 20 May when we informed you that the silence procedure was broken on the texts of the draft resolutions entitled "Review of the implementation of General Assembly resolution 72/305 on the strengthening of the Economic and Social Council" and "Review of the implementation of General Assembly resolutions 67/290 on format and organizational aspects of the high-level political forum on sustainable development and 70/299 on the follow-up and review of the 2030 Agenda for Sustainable Development at the global level" which were put under silence procedure in our letter of 12 May.

As you are aware, we continued to consult with delegations in the past few weeks and reflect to find solutions that address the remaining concerns. We hope that the revised final texts of the abovementioned resolutions, which we are placing under silence procedure until 12 pm EST on Thursday, 10 June 2021 will enjoy consensus.

We encourage all delegations to show flexibility so that we can adopt these important resolutions by consensus.

We very much want to thank you for the excellent cooperation we have had with you in the past few weeks and throughout this process.
