Excellency,

In its resolution 75/320 entitled "Scope, modalities, format and organization of the high-level meeting of the General Assembly to commemorate the twentieth anniversary of the adoption of the Durban Declaration and Programme of Action", in particular, operative paragraph 10, the General Assembly,

"Request[ed] the President of the General Assembly to draw up a list of representatives of other relevant non-governmental organizations, civil society organizations, academic institutions and the private sector who may participate in the high-level meeting, including its round tables, taking into account the principles of transparency and equitable geographical representation, with due regard for gender parity, to submit the proposed list to Member States for their consideration on a non-objection basis and to bring the list to the attention of the Assembly for a final decision by the Assembly on participation in the high-level meeting."

In this regard, I have the honour to enclose herewith for your consideration, a list of representatives of non-governmental organizations, civil society organizations, academic institutions and the private sector, which have applied to participate in the high-level meeting, including its round tables, to be held on Wednesday, 22 September 2021, at the UN Headquarters, New York.
