Further to my letter dated 17 September 2021, I have the honour to inform you that, in line with General Assembly resolution 75/320, and, without setting the precedent, I have invited the following representative of a non-governmental organization and a youth representative to address the Assembly at the opening of the High-level meeting of the General Assembly to commemorate the twentieth anniversary of the adoption of the Durban Declaration and Programme of Action, to be held at 9:00 a.m., on Tuesday, 22 September 2021, in the General Assembly Hall, UN Headquarters, New York:

- Dr. Barryl A. Biekman, Coordinator of the Monitoring Working Group on Durban Declaration and Program of Action and People of African Descent at Tiye International and Chair of The African European Women's Movement "Sophiedela" (pre-recorded statement);

I have the further honour to inform you that I intend to appoint Dr. Naledi Pandor, Minister of International Relations and Cooperation of the Republic of South Africa to chair the Round Table One and H.E. Mr. Pacôme Moubelet Boubeya, Minister of Foreign Affairs of the Gabonese Republic to chair the Round Table Two and present the summaries of the discussions to the Assembly at the closing plenary meeting. I invite the General Assembly to take relevant decision at the opening segment of the high-level meeting.
