BACKGROUND

The President of the General Assembly's Fellowship for Harnessing Opportunities for Promoting Empowerment of youth (PGA's Fellowship for HOPE) was born out of the core belief in the importance of youth participation. Young people must have a role in shaping the decisions that shape their lives in the present, and in the future.

The UN@75 declaration and the subsequent report of the Secretary-General entitled, "Our Common Agenda", clearly emphasized the need to invest in future generations, and the importance of empowering young people in the work of the United Nations. To invest in the future of multilateralism, we need to invest in young people and bring them closer to the work of the United Nations.

A key bottleneck faced by young people is the lack of opportunities available to gain relevant experience. This capacity constraint is even more acute in developing countries, which often do not have the resources to support young people's aspirations.

The Fellowship brings together young professionals from underrepresented countries at the United Nations, particularly from Least Developed Countries (LDCs), Landlocked Developing Countries (LLDCs), and Small Island Developing States (SIDS), while ensuring gender balance in representation.

The programme for the Fellows includes three main components:

(1) A training component led by the United Nations Institute for Training and Research (UNITAR), imparting information and interactive discussions on the United Nations, its organs, subsidiary bodies, and processes.

(2) Work Experience with the teams in the Office of the President of the General Assembly as well as with their respective Permanent Missions.

(3) A support and mentoring component to ensure that Fellows are adequately supported throughout the tenure of the programme.

PROGRAMME

The Fellowship partners with the United Nations Institute for Training and Research (UNITAR) to impart training on the United Nations, its organs, and subsidiary bodies. The trainings cover topics of importance such as sustainable development, climate change, peace and conflict resolution, and human rights as well as skills development in negotiation, drafting, and public diplomacy.

Fellows are attached on a rotational basis with the various teams of the Office of the President of the General Assembly (OPGA) - Peace and Security; Human Rights; Humanitarian; Sustainable Development; Reform, Legal and Budget; and Communications.

Through their work in the Office of the PGA, the Fellows gain an in-depth understanding of the workings of the United Nations system, ranging from the Secretariat to United Nations funds and programmes, specialized agencies, and other entities and bodies.

The Fellows also spend two days each week with their respective Permanent Missions to the United Nations to gain real experience of working in the six committees of the UN and following other UN processes.

Eleven Member States (Qatar, Italy, Kuwait, China, Slovak Republic, Portugal, Türkiye, Japan, Brunei, Switzerland, Australia) and the European Union contributed financially for the Fellowship during the 76th session of the UN General Assembly.

PERSPECTIVES FROM PERMANENT MISSIONS

UGANDA

The Mission is very supportive of the Fellowship programme as it enables capacity development and knowledge sharing amongst the Fellows as well as knowledge transfer. The programme also exposes the fellows to how the UN works, and gives them exposure to multilateralism and international diplomacy. The Permanent Mission of Uganda to the UN strongly supports its continuity.

With the generous support of the European Union and the Swiss Government, the HOPE Fellows undertook a study tour from 10-25 May 2022 to Brussels, Geneva, and Florence.

In Brussels, the Fellows learned about the work of the European Parliament, European Commission, Climate Diplomacy, and EU relations with their respective countries and others.

The Fellows met Ms. Eva Kaili, Vice President of the European Parliament and Mr. Stelios Makriyiannis, Chair of the European Union Working Party on the United Nations (CONUN), among other officials.

In Geneva, with the support of the Swiss Government, the Geneva Centre for Security Policy conducted a training course tailored for the Fellows, titled: "International Geneva: Managing 21st Century Peace and Security Challenges."

Over the course of five days, the Fellows were exposed to EU efforts/approaches in the areas of mediation and peace, human rights mechanisms, global migration and refugee challenges, COVID response, disarmament, and violent extremism.

The Fellows also had the privilege of paying a courtesy call on H.E. Mr. Ignazio Cassis, President of the Swiss Confederation and Minister of Foreign Affairs, and had an informal interaction with H.E. Mr. Joseph Diess, former Swiss President and PGA65.

In Florence, the training sessions took place at the School of Transnational Governance, which is part of the European University Institute (EUI).

The Fellows learned about the evolution of transnational governance and its context in the African, Caribbean, and Pacific regions. The sessions also covered sustainable business, global governance, and the European Climate Agenda.

The Fellows also had an opportunity to interact with Mr. Marco Del Panta, Secretary General of EUI, and concluded their study tour with an informal exchange with EUI Policy Leader Fellows on data as soft power.
