We are writing to you in our capacity as co-facilitators appointed by the President of the General Assembly to consult with Member States on the preparatory process for the High-level Dialogue on Financing for Development of the General Assembly - mandated by the Addis Ababa Action Agenda and convened every four years back-to-back with the High-level Political Forum under the auspices of the General Assembly to review progress on financing for development - which will take place in September 2023.

We are grateful to the President of the General Assembly for entrusting us with this important responsibility at a crucial time for the Financing for Development agenda. We look forward to working with all delegations in an open, transparent and inclusive manner.

For planning purposes, and in order to facilitate your participation, we are pleased to share with you a roadmap outlining the timing for our consultations. As indicated in the roadmap, we will convene a first meeting on Wednesday, 1 March 2023 from 10:00 a.m. until 1:00 p.m. in the Trusteeship Council Chamber. The aim of this meeting will be to brief delegations on the roadmap and to hear the views of Member States on the process, as well as their expectations for the High-level Dialogue.
