Excellency,

We have the honor to address you in our capacity as co-facilitators to produce a political declaration on the implementation of the United Nations Global Plan of Action to Combat Trafficking in Persons, to be adopted by the General Assembly at the opening segment of the high-level meeting of the General Assembly on the appraisal of the United Nations Global Plan of Action to Combat Trafficking in Persons. The high-level meeting will be held on Monday, 24 November, and Tuesday, 25 November 2025, in accordance with Resolution 79/286, adopted by the General Assembly on 29th April 2025.

With reference to your letter dated 1st May 2025, we are grateful for your decision to entrust us with the co-facilitation of this very important process. Once more, we are committed to facilitate the negotiation process in an open, transparent, inclusive and representative manner, with a view to producing a short and concise political declaration, as per operative paragraph 10 of the GA Resolution 79/286 requests. We look forward to the constructive participation of all delegations.

In this regard, we would like to share our proposed preliminary roadmap with a view to agree on a political declaration on the implementation of the United Nations Global Plan of Action to Combat Trafficking in Persons, the soonest. We take into serious consideration your kind request that the political declaration is finalized before the end of your mandate as the 79th President of the General Assembly.
