Wild rice (Wild rice), *Zizania*, belongs to the grass family, is a cereal grain, and has four species (namely, *Z.palustris*, *Z.aquatica*, *Z.texana*, and *Z.latifolia*), three naturally occurring in North America and one in Asia. The wild rice possesses a natural wild rice nutty taste and aroma.
