The Platform of FININT: Reporting Entity Efforts

- Within Anti-Terrorism Regime, often the front line is the reporting entities;
 - The reporting entities may be the first to detect suspicion;
 - Promoting Reporting Entity TF-vigilance to enhance STR Reporting;
 - STRs trigger new cases and potentially instigating a LE investigation
- Private sector have expanding corporate and AML/CTF risks, and have an interest in collaborating outside of the compliance context.

 Engaging and Educating our RE's strengthens a hostile environment for Terrorist Financing.

Extending the Outreach: New Areas of Sharing – Operationally-relevant TF Indicators

- FINTRAC has made significant efforts to grow past traditional outreach
- Began the process of developing unclassified indicators
- Recognition that a lone indicator is almost never a suspicion of terrorist financing, however, in the CTF context a person's financial activities leading up to attack planning / travelling abroad are vital in getting in front of the threat.


 Relationship between FIU & Supervision is key to enhance TF reporting.

Providing Global Access to Domestic Information


- Domestic information relevant to terrorism or terrorist financing investigation need to be accessible
- □ Example of information essential to combat TF:
 - National registries
 - Corporate information
 - Charities;
 - o Reporting Entities (e.g. Banks, MSBs)
 - Court documents
 - Administrative / criminal penalties information
 - Sanctions / Listed entities
 - Focusing on individuals & front organizations link to terrorist entities
 - Use of proper identifier
- Access to information leads to efficiency

 Formal channels are essential to international cooperation but informal channels are required to make it work.

Egmont ISIL Project - A model of international cooperation

- ISIL Multilateral Project Phase 1
 - 40 FIUs exploited their data sets to identify and track FTF's traveling to Iraq and the Levant.
- ISIL Multilateral Project Phase 2
 - Year long project will focus on uncovering new FTF facilitation networks.
- Presentations and training sessions on best practices and lessons learned

- Go beyond international assessments:
 - □ Assess the foreign agency safeguards of the information shared
- Use the indirect route
