Session III: Developing multidimensional responses to threats posed by misuse of UAS and enhancing States capabilities to reliably and sustainably prevent terrorists and other nefarious actors from acquiring and use of UAS and its components

- Best practices to strengthen state's capability to implement recovery and investigation measures
