

Background

Foreign terrorist fighter (FTF) returnees, relocators and their family members constitute a major challenge for countries in the OSCE area and worldwide.

Tackling these challenges goes beyond classic law enforcement and judicial cooperation and requires a holistic approach that includes, inter alia, effective border security and information sharing, preventing and countering incitement and recruitment to commit terrorist acts, judicial measures and international cooperation, protecting critical infrastructure and "soft" targets, as well as considering cross-cutting issues such as families and children, civil society and the role of gender.

Over the past years, legal and practical tools have been developed to tackle these challenges and to meet the needs of returnees as well as of communities where people will reintegrate.

The 2015 Madrid Guiding Principles and the 2018 Addendum are the United Nations practical tools to assist Member States in stemming the flow of FTF and in addressing matters related to returning and relocating FTFs and their family members pursuant to Security Council resolutions 2178 (2014) and 2396 (2017).
