AFRICA

Burundi: SG reports on the situation in Burundi

Resolution 2303 (2016) of 29 July 2016

Para.19: Requests the Secretary-General to report to the Security Council on the situation in Burundi <u>every three months</u> after the adoption of this resolution, including on any public incidents of incitements to hatred and violence, as well as on steps to ensure the deployment of the United Nations police component and on possible adaptations of the United Nations police component as referred to in paragraphs 13 and 14 of this resolution, and further requests the Secretary-General to provide written reports immediately to the Security Council, as necessary, on grave security incidents, violations of international humanitarian law and violations or abuses of human rights, as applicable, of which the United Nations police component in Burundi, together with OHCHR, has knowledge, whoever perpetrates them;

The Secretary-General is expected to report in October 2016.

Burundi: SG proposals to enable the UN to facilitate the deployment of the AU observers and on modalities for cooperation between the United Nations police component and AU observers

Resolution 2303 (2016) of 29 July 2016

Para.11: Requests the Secretary General to report to the Security Council <u>within 30 days</u>, in close coordination with the AU, on proposals to enable the United Nations to facilitate the deployment of the AU observers and on modalities for cooperation between the United Nations police component, as referred to in paragraph 13 of this resolution, and the AU observers, taking into account their comparative advantages and within their respective mandates, in compliance with the United Nations standards and practices and consistent with the United Nations Human Rights Due Diligence Policy;

CAR: SG reports on the situation in CAR and MINUSCA

mechanisms and capacity to advance governance and fiscal management, relevant information on the progress, promotion and protection of human rights and international humanitarian law as well as a review of the troop and police levels, force and police generation and deployment of all MINUSCA's constituent elements;

CAR: France to report to SC on implementation of mandate to support MINUSCA Resolution 2301 (2016) of 26 July 2016

Para.56: Authorizes French forces, within the limits of their capacities and areas of deployment, from the commencement of the activities of MINUSCA until the end of MINUSCA's mandate as authorized in this resolution, to use all necessary means to provide operational support to elements of MINUSCA from the date of adoption of this resolution, at the request of the Secretary-General, and requests France to report to the Council on the implementation of this mandate and to coordinate its reporting with that of the Secretary-General referred to in paragraph 58 of this resolution;

DRC: SG reports on MONUSCO

Resolution 2277 (2016) of 30 March 2016

Para.50: Requests the Secretary-General to report to the Council <u>every three months</u> on the implementation of MONUSCO's mandate, including its Intervention Brigade, as set out in this resolution, including on:

(i) the situation on the ground, including updates on operations to neutralize armed groups and any instances where the Mission's protection of civilians obligations are not fully met, as well as sexual violence and the impact of conflict on women and children;

(ii) progress made by the DRC on protecting human rights, on the electoral process, including on the provisions of paragraphs 7, 8 and 9 above, and in the implementation of its commitments under the PSC Framework, including through the establishment and implementation of a national SSR roadmap, its provincial stabilisation plan supported by the ISSSS and on the implementation of the DDR and DDRRR plans;

(iii) progress in the implementation of the recommendations of the strategic review, notably the measures taken to transform MONUSCO's Force, including the deployment of rapidly deployable battalions, to become more efficient and effective in implementing its mandate;

South Sudan: Sanctions: Panel of Experts report to SC on security threats facing the TGNU and the role of transfers of arms and related materiel

(ii) information on violations of the Status of Forces Agreement, including those involving attacks or threats of attack on UNAMID, violations of international humanitarian law perpetrated by any party to the conflict, as well as access restrictions and significant operational obstacles such as those related to customs clearances and visas;

(iii) developments and progress towards achievement of UNAMID's strategic priorities and benchmarks, including progress in response to the Secretary General's recommendations on practical steps requested in paragraph 33 of this resolution;

(iv) developments and progress in addressing the challenges facing UNAMID as identified in the review of UNAMID; and

(v) on the implementation of this resolution;

The authorisations will expire on 9 October 2016.

Maintenance of international peace & security: Migrant smuggling: Authorisation to seize inspected vessels being used for migrant smuggling or human trafficking from Libya Resolution 2240 (2015) of 9 October 2015

Para.8: Decides to authorise for a period of <u>one year</u> from the date of the adoption of this resolution, Member States acting nationally or through regional organisations to seize vessels inspected under the authority of paragraph 7 that are confirmed as being used for migrant smuggling or human trafficking from Libya, and underscores that further action with regard to such vessels inspected under the authority of paragraph 7, including disposal, will be taken in accordance with applicable international law with due consideration of the interests of any third parties who have acted in good faith;

The authorisations will expire on <u>9 October 2016</u>.
