**AFRICA**

**Burundi: SG reports on the situation in Burundi**

S/PRST/2017/13 of 2 August 2017

Antepenultimate para: The Security Council recalls its request [in para.19 of resolution 2303 (2016) of 29 July 2016] to the Secretary-General to report to the Security Council on the situation in Burundi every three months, to be reviewed after one year, including on any public incidents of incitements to hatred and violence, and changes to the situation on the ground, and *further requests* the Secretary-General to provide written reports immediately to the Security Council, as necessary, on grave security incidents, violations of international humanitarian law and violations or abuses of human rights, as applicable, of which the United Nations in Burundi has knowledge, whoever perpetrates them.

The Secretary-General is expected to report in May 2018.

**CAR: SG to present recommendations to SC on support to redeployment of FACA units**

Resolution 2387 (2017) of 15 November 2017

Para.43 (a)(iv): On the basis of the 2017–2019 Guidance Document for the Redeployment of CAR armed forces, requested by resolution [2301 \(2016\)](#), to consider providing support to the progressive and coordinated redeployment of FACA units trained by EUTM-RCA, as an element of the strategy for the extension of State authority, in accordance with the United Nations HRDDP and with the guarantee that it does not constitutes a risk to the stabilization of the country, civilians or the political process, and requesting the Secretary-General to present recommendations, with detailed benchmarks and timelines, to the Security Council for its consideration and possible approval within 6 months of the adoption of this resolution, while keeping in mind that technical agreements between the United Nations and donors could be considered to support the CAR defence forces;

The report of the Secretary-General is expected to be issued in May 2018.

**Central African region: SG reports on UNOCA**

S/PRST/2015/12 of 11 June 2015

Last para.: The Security Council requests that the Secretary-General keep it informed through a report on the situation in Central Africa and UNOCA's activities to be submitted before 30 November 2015 and every six months thereafter, on the activities of UNOCA, progress made in conducting assessments of the LRA's evolving area of operations and logistical and support networks, and the efforts being undertaken respectively by missions in the region and relevant United Nations agencies to implement the UN's Regional Strategy.

The report of the Secretary-General is expected to be issued in May 2018.

**DRC: SG to update SC on progress towards 23 December 2018 elections, including implementation of election benchmarks and obstacles to implementation of the 31 December 2016 agreement**

Resolution 2409 (2018) of 27 March 2018

Para. 61: Requests the Secretary-General to update the Security Council in writing every 30 days on political and technical progress towards 23 December 2018 elections, including benchmarks laid out in paragraph 7 above and obstacles to the implementation of the 31 December 2016 agreement, when no regular reports are due;

The report of the Secretary-General is expected to be issued in May 2018.

**Guinea-Bissau: SG to provide oral update on the political and security situation and preparations for elections**

Resolution 2404 (2018) of 28 February 2018

Para.28: Requests the Secretary-General to provide an oral update within 3 months on the political and security situation in Guinea Bissau and its preparation for elections, and submit to the Security Council regular reports every six months on the implementation of this resolution, and within 9 months submit the Secretary-General's assessment of the Mission including options for a possible reconfiguration of the United Nations presence in the country and re-prioritization of tasks, and to submit a report within six months, with a briefing to the Committee established pursuant to its resolution [2048 \(2012\)](#), on the progress made with regards to the stabilization of the country and restoration of constitutional order and recommendations on the continuation of the sanctions regime in the post-election environment, in line with paragraph 12 of resolution [2048 \(2012\)](#);

The Secretary-General is expected to report in May 2018.

**Libya: UNSMIL: SG to report to SC on the implementation of resolution 2376 (2017)**

Resolution 2376 (2017) of 14 September 2017

Para.7: Requests the Secretary-General to continue to report to the Security Council on the implementation of this resolution at least every 60 days;

The report of the Secretary-General is expected to be issued in May 2018.

**Libya: SG to report on the implementation of resolution 2357 (2017) (authorization to inspect vessels)**

Resolution 2357 (2017) of 12 June 2017

Para.2: Requests the Secretary-General to report to the Security Council within eleven months of the adoption of this resolution on its implementation;

The report of the Secretary-General is expected to be issued in May 2018.

**Libya: ICC Prosecutor briefing**

Resolution 1970 (2011) of 26 February 2011

Para.7: Invites the Prosecutor to address the Security Council within two months of the adoption of this resolution and every six months thereafter on actions taken pursuant to this resolution.

The ICC Prosecutor is expected to brief in May 2018.

**Somalia: AMISOM mandate**

Resolution 2372 (2017) of 30 August 2017

Para.5: Decides to authorize the Member States of the AU to maintain the deployment of AMISOM until 31 May 2018, and to reduce the level of uniformed AMISOM personnel to a maximum level of 21,626 by 31 December 2017, to include a minimum of 1,040 AMISOM police personnel including five Formed Police Units, with a further reduction of uniformed personnel to 20,626 by 30 October 2018, unless the Security Council decides to accelerate the pace of the reduction, taking into account the capabilities of the Somali security forces thus far;

The mandate will expire on 31 May 2018.

**Somalia: AMISOM: SG reports on the implementation of resolution 2372 (2017)**

Resolution 2372 (2017) of 30 August 2017

Para.54: Requests the Secretary-General to keep the Security Council regularly informed on the implementation of this resolution in his regular reports, including through oral updates and no fewer than three written reports, with the first written report by 12 January 2018, and every 120 days thereafter;

The report of the Secretary-General is expected to be issued in May 2018.

**Somalia: UNSOM: SG reports on the implementation of resolution 2408 (2018)**

Resolution 2408 (2018) of 27 March 2018

Para. 28: Requests the Secretary-General to keep the Security Council regularly informed on the implementation of this resolution, identify and report on progress towards achieving key political benchmarks, including through oral updates and no fewer than three written reports, with the first written report by 1 May 2018 and every 120 days thereafter;

The report of the Secretary-General is expected to be issued in May 2018.

**Somalia: SG report on the future funding of AMISOM**

Resolution 2372 (2017) of 30 August 2017

Para.32: Stresses the need to enhance the predictability, sustainability and flexibility of financing for African Union-led peace support operations authorized by the Security Council and under the Security Council's authority consistent with Chapter VIII of the Charter, urges the Secretary-General, African Union and partners to explore in earnest funding arrangements for AMISOM, bearing in mind the full range of options available to the United Nations, African Union, the European Union, and to other partners, and considering the limitations of voluntary funding, in order to establish secure future funding arrangements for AMISOM, and looks forward to the Secretary-General's report on the future funding of AMISOM by November 2017;

PSC letter of 4 December 2017 (S/2017/1018)

I have the honour to inform you that your letter dated 30 November 2017 (S/2017/1017) concerning your intention to submit the report on the future funding of the African Union Mission in Somalia by the end of February 2018, has been brought to the attention of the members of the Security Council. They take note of the information contained in your letter and the intention expressed therein.

The report dated 19 April 2018 is before the Security Council.

### **South Sudan: Sanctions: Travel ban and assets freeze**

#### Resolution 2353 (2017) of 24 May 2017

Para. 1: Decides to renew until 31 May 2018 the measures imposed by paragraphs 9 and 12 of resolution [2206 \(2015\)](#), and reaffirms the provisions of paragraphs 10, 11, 13, 14 and 15 of resolution [2206 \(2015\)](#), and the provisions of paragraphs 8, 9 and 10 of resolution [2290 \(2016\)](#);

The travel ban and assets freeze will expire on 31 May 2018.

### **South Sudan: Sanctions: Panel of Experts final report**

#### Resolution 2353 (2017) of 24 May 2017

Para. 2: Decides to extend until 30 June 2018 the mandate of the Panel of Experts as set out in subparagraphs (a), (b), (c), (e) and (f) of paragraph 12 of resolution [2290 \(2016\)](#), and decides that the Panel of Experts should provide to the Council, after discussion with the Committee, an interim report by 1 December 2017, a final report by 1 May 2018, and, except in the months when these reports are due, updates each month, and expresses its intention to review the mandate and take appropriate action regarding the further extension of the mandate no later than 31 May 2018;

The final report of the PoE dated 2 April 2018 (S/2018/292) is before the Security Council.

### **South Sudan: Sanctions: SC review of Panel of Experts mandate**

#### Resolution 2353 (2017) of 24 May 2017

Para. 2: Decides to extend until 30 June 2018 the mandate of the Panel of Experts as set out in subparagraphs (a), (b), (c), (e) and (f) of paragraph 12 of resolution [2290 \(2016\)](#), and decides that the Panel of Experts should provide to the Council, after discussion with the Committee, an interim report by 1 December 2017, a final report by 1 May 2018, and, except in the months when these reports are due, updates each month, and expresses its intention to review the mandate and take appropriate action regarding the further extension of the mandate no later than 31 May 2018;

The Security Council is expected to take action no later than 31 May 2018.

### **South Sudan: Sanctions: SC to monitor and review situation**

#### Resolution 2290 (2016) of 31 May 2016

Para. 15: Expresses its intent to monitor and review the situation at 90-day intervals from the adoption of this resolution or more frequently, as needed, and invites the JMEC to share relevant information with the Council, as appropriate, on its assessment of the parties' implementation of the Agreement, adherence to the permanent ceasefire, and facilitation of humanitarian access, also expresses its intent to impose any sanctions that may be appropriate to respond to the situation, which may include an arms embargo and the designation of senior individuals responsible for actions or policies that threaten the peace, security or stability of South Sudan, including by impeding the implementation of the Agreement, or by failing to take effective and comprehensive steps to cause forces under direct or indirect control to cease military operations, acts of violence, as well as human rights violations or abuses or violations of international humanitarian law, and to enable full access for humanitarian assistance;

The Security Council is expected to monitor and review the situation in May 2018.

### **Sudan/South Sudan: UNISFA mandate**

#### Resolution 2386 (2017) of 15 November 2017

Para.1: Decides to extend until 15 May 2018 the mandate of the United Nations Interim Security Force for Abyei (UNISFA) as set out in paragraph 2 of resolution [1990 \(2011\)](#) and acting under Chapter VII of the Charter of the United Nations, further decides to extend until 15 May 2018 the tasks of UNISFA as set out in paragraph 3 of resolution [1990 \(2011\)](#);

The mandate will expire on 15 May 2018.

### **Sudan: SG reports on UNAMID**

#### Resolution 2363 (2017) of 29 June 2017

Para.41: Requests the Secretary-General to report to the Council every 60 days following adoption of this resolution on UNAMID, including:

- (i) information on the political, humanitarian and security situation in Darfur, including detailed reporting on incidents of violence and attacks against civilians, including sexual and gender-based violence, by whomsoever perpetrated;
- (ii) information on violations of the Status of Forces Agreement, including those involving attacks or threats of attack on UNAMID, violations of international humanitarian law perpetrated by any party to the conflict, as well as access restrictions and significant operational obstacles such as those related to customs clearances and visas;
- (iii) developments and progress towards achievement of UNAMID's strategic priorities and benchmarks;
- (iv) progress in the implementation of the recommendations made in the Special Report, including the progress of reductions to UNAMID's military and police component and its impact, including on protection needs and violations and abuses of human rights;
- (v) developments and progress on strategically addressing the underlying drivers of inter-communal conflict and the action plan on the prevention and resolution of inter-communal conflict;
- (vi) developments and progress in addressing the challenges facing UNAMID;
- (vii) enhanced, detailed and full information on abuses and violations of human rights, including those committed against women and children and violations of international humanitarian law;
- (viii) developments regarding UNAMID's support for local conflict resolution mechanisms, including progress regarding the full and effective participation of women; and
- (ix) on the implementation of this resolution;

The report of the Secretary-General dated 25 April 2018 (S/2018/389) is before the Security Council.

## ASIA/MIDDLE EAST

### **Iraq: SG reports on UNAMI**

Resolution 2367 (2017) of 14 July 2017

Para.6: Requests the Secretary-General to report to the Council every three months on the progress made towards the fulfilment of all UNAMI's responsibilities;

The report of the Secretary-General dated 17 April 2018 (S/2018/359) is before the Security Council.

### **Iraq/Kuwait: missing persons and return of property**

Resolution 2107 (2013) of 27 June 2013

Para.4: requests that the Special Representative of the Secretary-General and Head of the United Nations Assistance Mission to Iraq (UNAMI) promote, support and facilitate efforts regarding the repatriation or return of all Kuwaiti and third country nationals or their remains, and the return of Kuwaiti property, including the national archives, seized by Iraq, further requests the Secretary-General to report separately to the Security Council on these matters in his reports on the progress made towards the fulfilment of all UNAMI's responsibilities....;

The report of the Secretary-General dated 14 April 2018 (S/2018/353) is before the Security Council.

### **Middle East: The situation in the Middle East, including the Palestinian question**

Resolution 1322 (2000) of 7 October 2000

Para.7: Invites the Secretary-General to continue to follow the situation and to keep the Security Council informed.

### **Middle East (Lebanon): SG reports on resolution 1559 (2004)**

Resolution 1559 (2004) of 2 September 2004

Para.7: Requests that the Secretary-General report to the Security Council within thirty days on the implementation by the parties of this resolution and decides to remain actively seized of the matter.

S/PRST/2004/36 of 19 October 2004

Last para.: The Security Council appreciates the Secretary-General's intention to keep the Council updated. It requests that he continue to report on the implementation of the resolution to the Council every six months.

The report of the Secretary-General is expected to be issued in May 2018.

### **Middle East (Syria): OPCW DG to report to SC (through SG) on impl. of resolution 2118 (2013)**

Resolution 2118 (2013) of 27 September 2013

Para.12: Decides to review on a regular basis the implementation in the Syrian Arab Republic of the decision of the OPCW Executive Council of 27 September 2013 and this resolution, and requests the Director-General of the OPCW to report to the Security Council, through the Secretary-General, who shall include relevant information on United Nations activities related to the implementation of this resolution, within 30 days and every month thereafter, and requests further the Director-General of the OPCW and the Secretary-General to report in a coordinated manner, as needed, to the Security

Council, non-compliance with this resolution or the OPCW Executive Council decision of 27 September 2013.

The report is expected to be presented in May 2018.

**Middle East (Syria): SG to report on implementation of resolutions 2139 (2014), 2165 (2014), 2191 (2014), 2258 (2015), 2332 (2016) and 2393 (2017)**

Resolution 2139 (2014) of 22 February 2014

Para.17: Requests the Secretary-General to report to the Council on the implementation of this resolution by all parties in Syria, in particular paragraphs 2 through 12, in 30 days of its adoption and every 30 days thereafter, and upon receipt of the Secretary-General's report, expresses its intent to take further steps in the case of non-compliance with this resolution;

Resolution 2393 (2017) of 19 December 2017

Para.6: Requests the Secretary-General to report to the Council on the implementation of this resolution, and on compliance by all relevant parties in Syria, within the framework of its reporting on resolutions [2139 \(2014\)](#), [2165 \(2014\)](#), [2191 \(2014\)](#), [2258 \(2015\)](#) and [2332 \(2016\)](#) and further requests the Secretary-General to include in his monthly reports overall trends in UN cross-line and cross-border humanitarian access, and more detailed information on the humanitarian assistance delivered through UN humanitarian cross-border operations as authorized by UNSCR [2165 \(2014\)](#), including on the number of beneficiaries, locations of aid deliveries at district-level, and the volume and nature of items delivered;

**Middle East (Syria): SG to report to SC on the implementation of resolution 2401 (2018) and compliance by parties**

Resolution 2401 (2018) of 24 February 2018

Para.12: Requests the Secretary-General to report to the Council on the implementation of this resolution, and on compliance by all relevant parties in Syria, within 15 days of adoption of this resolution and thereafter within the framework of its reporting on resolutions [2139 \(2014\)](#), [2165 \(2014\)](#), [2191 \(2014\)](#), [2258 \(2015\)](#), [2332 \(2016\)](#) and [2393 \(2017\)](#);

The report of the Secretary-General is expected to be issued in May 2018.

**Middle East (Syria): SG report on the implementation of resolution 2268 (2016)**

Resolution 2268 (2016) of 26 February 2016

Para.10: Requests the Secretary-General to report to the Council on the implementation of this resolution, including by drawing on information provided by the ISSG ceasefire taskforce, and on resolution 2254 (2015), within 15 days of the adoption of this resolution and every 30 days thereafter;

The Secretary-General is expected to report in May 2018.

## EUROPE

### **UNMIK: SG report**

Resolution 1244 (1999) of 10 June 1999

Para.20: Requests the Secretary-General to report to the Council at regular intervals on the implementation of this resolution, including reports from the leaderships of the international civil and security presences, the first reports to be submitted within 30 days of the adoption of this resolution;

The report of the Secretary-General is expected to be issued in May 2018.

### **BiH: Reports of High Representative to SC thru SG**

Resolution 2183 (2014) of 11 November 2014

Para.20: Also requests the Secretary-General to continue to submit to the Council reports from the High Representative, in accordance with annex 10 of the Peace Agreement and the conclusions of the Peace Implementation Conference held in London on 4 and 5 December 1996 (S/1996/1012), and later Peace Implementation Conferences, on the implementation of the Peace Agreement and in particular on compliance by the parties with their commitments under that Agreement;

The report of the High Representative is expected to be submitted in May 2018.

### **BiH: EUFOR ALTHEA/NATO reports to SC**

Resolution 2183 (2014) of 11 November 2014

Para.18: Requests the Member States acting through or in cooperation with the EU and the Member States acting through or in cooperation with NATO to report to the Council on the activity of EUFOR ALTHEA and NATO Headquarters presence respectively, through the appropriate channels and at least at six-monthly intervals;

## OTHER

### **Non-proliferation/DPRK: Sanctions: 1718 Committee reports**

Resolution 1718 (2006) of 14 October 2006

Para.12: Decides to establish, in accordance with rule 28 of its provisional rules of procedure, a Committee of the Security Council consisting of all the members of the Council, to undertake the following tasks:

(g) To report at least every 90 days to the Security Council on its work, with its observations and recommendations, in particular on ways to strengthen the effectiveness of the measures imposed by paragraph 8 above.

The Chair of the 1718 Committee is expected to brief in May 2018.

### **Peace and security in Africa: SG to report to SC on activities of the Force conjointe du G5 Sahel**

Resolution 2391 (2017) of 8 December 2017

Para.33: Requests the Secretary-General, in close coordination with the G5 Sahel States and the African Union, to report to the Security Council on the activities of the FC-G5S, five months after the adoption of this resolution and then every six months, focusing:

(i) on progress in the operationalization of the FC-G5S,

(ii) on international support granted to the FC-G5S and possible measures to enhance its efficiency,  
(iii) on implementation of the technical agreement, including through a detailed outline of the support provided by MINUSMA to the FC-G5S, an assessment of its potential impact on MINUSMA as well as the provision of benchmarks to indicate the level of operationalization of the FC-G5S at which MINUSMA's logistical and operational support may be gradually withdrawn,  
(iv) on challenges encountered by the FC-G5S and possible measures for further consideration,  
(v) on implementation by the G5 Sahel States of the compliance framework, the HRDDP, as well as on ways to mitigate any adverse impact of the military operations of the FC-G5S on the civilian population, including on women and children;

The report of the Secretary-General is expected to be issued in May 2018.

**Protection of civilians in armed conflict: SG reports to SC**

S/PRST/2015/23 of 25 November 2015

Last para.: The Security Council takes note of with appreciation the report of the Secretary-General on the protection of civilians in armed conflict of 18 June 2015 (S/2015/453) and the recommendations contained therein, and reiterates the need for systematic monitoring and reporting on the protection of civilians in armed conflict, and the challenges and progress made in this regard. The Security Council requests the Secretary-General to submit his next report on the protection of civilians in armed conflict by 15 May 2016 and to submit future reports every 12 months thereafter, to be formally considered by the Security Council each year within the same General Assembly session.

The report of the Secretary-General is expected to be issued in May 2018.

**Protection of civilians in armed conflict: (Health care in armed conflict): SG briefing on the implementation of resolution 2286**

Resolution 2286 (2016) of 3 May 2016

Para. 14: Further requests the Secretary-General to brief the Security Council every twelve months on the implementation of this resolution.

The Secretary-General is expected to brief the Security Council in May 2018.

**Residual Mechanism: Report on progress since review of Mechanism in December 2015**

S/PRST/2018/6 of 19 March 2018

Para. 5.: "The Security Council requests the Mechanism to present by 15 April 2018 its report on the progress of its work since the last review of the Mechanism in December 2015, including in completing its functions, with detailed schedules for the proceedings currently under consideration as well as factors relevant to projected completion dates for the cases and other matters over which the S/PRST/2018/6 2/2 18-04288 Mechanism has jurisdiction, including in accordance with the Transitional Arrangements in Annex 2 to resolution 1966 (2010) ("report").

The progress report of the President of the Mechanism dated 13 April 2018 (S/2018/347) is before the Security Council.
