

#### A. STATISTICS OF SECURITY COUNCIL ACTIVITIES

#### **Security Council meetings and decisions/press statements**

1. In 2011, the Security Council held 235 meetings: there were 213 public meetings and 22 private meetings (including 13 private meetings with police-and troop-contributing countries (P/TCCs)). The Council also held 182 consultations, adopted 66 resolutions (43 were adopted under Chapter VII of the Charter of the United Nations), issued 22 presidential and 74 press statements. For a historical comparison of statistics relating to Council meetings and decisions/press statements over the last 11 years, see Charts 1a and 1b below.

#### **Meetings**


2. *Breakdown by agenda items*: Over two-thirds of the meetings (177) in 2011 dealt with country-specific/regional situations with the remaining one-third (58) concerning thematic and cross-cutting issues. The most frequently discussed agenda items in 2011 were "Reports of the Secretary-General on the Sudan", "The situation in Libya", and "The situation in Somalia" (See Chart 6 for more details). In the meetings dealing with country-specific/regional situations, the regional distribution shows that Africa accounted for 68% of the meetings in that category, followed by the Middle East (15%), Asia (7%), Europe (7%) and the Americas (3%) see Chart 2.




Chart 3: Number of newly introduced agenda items from 2001 to 2011

- 5. In reference to the "Summary statement by the Secretary-General on matters of which the Security Council is seized and on the stage reached in their consideration", no items were deleted.
- 6. *Agenda items discussed*: In the course of 2011, the Council discussed a total of 51 agenda items: 27 dealing with country-specific/regional situations and 24 with thematic thematic/crosscutting agenda items (for more details, see Annex 1).

#### **Voting**

7. **Resolutions**: The Council continued to adopt the majority of its resolutions unanimously. Out of 68 resolutions, 3 were adopted without unanimity (Table 3) and 2 vetoed due to the negative votes of permanent members (Table 4).



#### **Security Council Missions**

9. Missions consisting of members of the Security Council visiting the field have occurred since 1964.<sup>5</sup> In recent years many of these missions have consisted of representatives of all fifteen members of the Council. While the Security Council started to undertake missions to Africa since 1970,<sup>6</sup> it did not do so regularly in subsequent years. It was only from 2000 onwards that the Council conducted missions to Africa on an annual basis (Chart 5). In 2011, the Council conducted one major mission to Africa visiting Ethiopia, Sudan, and Kenya from 19 to 26 May.





Chart 5: Security Council Missions (2001 to 2011)

## **B. HIGHLIGHTS**

## **Briefings**

10. *First-time briefings*: The Council was briefed for the first time by the following persons under the designated agenda items: (1) Director for the 2011 World Development Report of the World Bank; (2) Head of the United Nations Office to the African Union; (3) SRSG and Head of the UN Regional Office for Central Africa; (4) Secretary-General of the Economic Community of Central African States; (5) Director for International Law and Cooperation of the International Committee of the Red Cross; (6) SRSG for South Sudan and Head of the United Nations Mission in South Sudan; and (7) Director-General of the World Health Organization (Table 5).

11. **Briefings via video teleconference:** In 2011, the Council increasingly utilized video teleconferencing (VTC) to receive timely briefings by relevant briefers in field missions and high-level personnel on the ground on the issue under consideration. In comparison to 2010, the use of VTC in 2011 increased by 100% (Chart 7).



#### **United Nations Membership**

- 12. *Admission of the Republic of South Sudan*: The Council, on 11 July 2011, referred the application of the Republic of South Sudan for admission to its Committee on the Admission of New Members. On the basis of the Committee's report, the Council adopted resolution 1999 on 13 July 2011 without a vote, recommending to the General Assembly the admission of the Republic of South Sudan to membership in the United Nations.
- 13. *Palestine's application for admission to UN membership*: On 23 September 2011, Palestine submitted an application for membership (S/2011/592) to the Secretary-General, who transmitted the application to the Security Council. The Security Council, on 28 September 2011, referred the application of Palestine to its Committee on the Admission of New Members which was unable to make a unanimous recommendation to the Security Council.

#### Deployment of an assessment mission

14. As a result of piracy and armed robbery aboard vessels along the coast of West Africa, the Security Council adopted resolution 2018 of 31 October 2011, by which it condemned all acts of piracy and armed robbery at sea committed off the coast of the Gulf of Guinea and welcomed the intention of the Secretary-General to deploy a United Nations assessment mission to examine the threat of piracy and armed robbery at sea, in the Gulf of Guinea and explore options on how best to address the problem. The mission was dispatched from 7 to 24 November and reported back to the Security Council on 29 February 2012.

## **Sanctions**

- 15. In 2011, the Security Council imposed targeted sanctions against individuals obstructing the peace process in Côte d'Ivoire, as well as established new sanctions measures against the Libyan Arab Jamahiriya and the Taliban. In addition, the Council expanded the mandate of the Monitoring Group on Somalia and Eritrea and established a separate list for Taliban individuals and entities subject to sanctions.
- 16. *Establishment of new sanctions measures against the Libyan Arab Jamahiriya*: In the wake of the violence and use of force against civilians, by resolution 1970 of 26 February, the Security Council, taking measures under Article 41 of the Charter, imposed an arms embargo and other arms restrictions as well as targeted sanctions (travel ban and asset freeze) against key regime figures in the Libyan Arab Jamahiriya. It also established a new sanctions Committee.
- 17. *Imposition of sanctions measure targeting individuals in Côte d'Ivoire:* During the postelectoral crisis in Côte d'Ivoire, the Security Council, by resolution 1975 of 30 March 2011, adopted targeted financial and travel sanctions against individuals, including former President Laurent Gbagbo, who obstructed peace and reconciliation in Côte d'Ivoire, obstructed the work of UNOCI and other international actors, and committed serious violations of human rights and international humanitarian law.

- 18. *Establishment of new sanctions regime against the Taliban:* By resolution 1988 of 17 June 2011, the Council, with the aim of further supporting an Afghan-led and -owned political dialogue for sustainable peace in Afghanistan, decided to establish a new sanctions regime and requested all States to take measures (asset freeze, travel ban, arms embargo) in connection with any individuals, groups, undertakings and entities associated with the Taliban in constituting a threat to the peace, stability and security of Afghanistan as designated by the Committee established pursuant to the same resolution.
- 19. Strengthening the mandate of the Monitoring Group on Somalia and Eritrea: On 26 July 2011, the mandate of the Monitoring Group on Somalia and Eritrea was expanded. In doing so, the Council decided that the measures stipulated in resolution 1844 (2008) should include individuals and entities found to be recruiting or using children in armed conflicts in Somalia and found to be responsible for violations of applicable international law in Somalia involving the targeting of civilians including children and women in situations of armed conflict, including killing and maiming, sexual and gender based violence, attacks on schools and hospitals and abduction and forced displacement.<sup>7</sup>
- 20. *Strengthening the mandate of the Ombudsperson of the 1267 Committee:* On 17 June 2011, the Security Council, by resolution 1989 defined the process for the presentation of recommendations of the Ombudsperson to the 1267 Committee, and imposed time limits on the considerations for de-listing.<sup>8</sup>
- 21. *Children and armed conflict:* By resolution 1998 of 12 July 2011, the Council requested the Secretary-General to include in the annexes to his reports on children and armed conflict those parties to armed conflict that engaged (a) in recurrent attacks on schools and/or hospitals and (b) in recurrent attacks or threats of attacks against protected persons in relation to schools and/or hospitals. The Council also expressed its intention, when establishing, modifying or reviewing the mandate of relevant sanctions regimes, to consider including provisions pertaining to parties to armed conflict that engaged in activities in violation of applicable international law relating to the rights and protection of children in armed conflict.

#### **International Criminal Court**

- 22. *Referral to the International Criminal Court*: By resolution 1970 of 26 February 2011, the Council, taking measures under its Article 41, decided to refer the situation in the **Libyan Arab Jamahiriya** since 15 February 2011 to the Prosecutor of the International Criminal Court.
- 23. *Jurisdiction of the International Criminal Court*: By resolution 1975 of 30 March 2011, the Council considered that the attacks taking place in Côte d'Ivoire against the civilian population could amount to crimes against humanity and that perpetrators of such crimes must be held accountable under international law and noted that the International Criminal Court may decide

on its jurisdiction over the situation in **Côte d'Ivoire** on the basis of Article 12, paragraph 3 of the Rome Statute.

## **Subsidiary organs of the Security Council**

- 24. In 2011, the Council established two peacekeeping missions in South Sudan and Abyei and one political mission in Libya, and terminated the peacekeeping mission in the Sudan and the political mission in Nepal. In addition, it modified the mandate of the United Nations Operation in Côte d'Ivoire by temporarily increasing its strength.
- 25. *Establishment of a peacekeeping mission in Abyei*: Following the Agreement between the Government of Sudan and the Sudan People's Liberation Movement on Temporary Arrangements for the Administration and Security of the Abyei Area, the Security Council, by resolution 1990 of 27 June 2011 established the United Nations Interim Security Force for Abyei (UNISFA) for an initial period of six months.
- 26. *Establishment of a peacekeeping mission in South Sudan:* While welcoming the establishment of the Republic of South Sudan on 9 July 2011, upon its proclamation as an independent state, the Security Council, by resolution 1996 decided to establish as of 9 July 2011 the United Nations Mission in the Republic of South Sudan (UNMISS) for an initial period of one year.
- 27. *Establishment of a political mission in Libya:* On 16 September 2011, the Security Council, by resolution 2009 established the United Nations Support Mission in Libya (UNSMIL) for an initial period of three months, to support the country's new transitional authorities in their post-conflict efforts.
- 28. *Termination of the peacekeeping mission in Sudan*: In response to a letter from the Minister for Foreign Affairs of the Sudan informing the Secretary-General of his Government's decision to terminate the presence of the United Nations Mission in the Sudan (UNMIS), the Security Council decided by resolution 1997 of 11 July 2011 to withdraw UNMIS effective 11 July 2011 and called on the Secretary-General to complete the withdrawal of all uniformed and civilian UNMIS personnel, except those needed for the Mission's liquidation, by 31 August 2011.
- 29. *Termination of the political mission in Nepal*: The mandate of the United Nations Mission in Nepal (UNMIN) which had supported the peace process since 2006, ended on 15 January 2011. In its presidential statement, the Council called on the Nepalese caretaker Government and all political parties to redouble their efforts to continue to work together in the spirit of consensus to fulfill the commitments they had made in the Comprehensive Peace Agreement and other agreements.<sup>9</sup>
- 30. Mandate change of the United Nations Operation in Côte d'Ivoire (UNOCI): Temporary increase in strength: As a result of the continued violence and human rights violations in Côte d'Ivoire, the Council decided to authorize, as recommended by the Secretary-General the following: the deployment of an additional 2,000 military personnel to UNOCI until 30 June

2011; the transfer, on a temporary basis of three armed helicopters with crews from the United Nations Mission in Liberia (UNMIL) to UNOCI for a period of four weeks; and the deployment of 60 formed police unit personnel to meet threats posed by unarmed crowds.<sup>10</sup>

## **Women and Peace and Security**

- 31. On 28 October 2011, the Council reviewed progress on the implementation of its landmark resolution 1325 (2000), issuing a presidential statement which expressed concern over the persistence of gaps and challenges that hindered the implementation of resolution 1325 (2000), including the continued low numbers of women in formal institutions of conflict prevention and resolution, particularly in preventive diplomacy and mediation efforts. Moreover, it requested the Secretary-General in his next annual report on resolution 1325 (2000) to include, inter alia, a comprehensive overview of specific actions, achievements and challenges with regard to the participation of women in mediation and preventive diplomacy. <sup>11</sup>
- 32. *Implementation of resolution 1325*: In 2011, the Security Council took note of the following high-level female appointments made by the Secretary-General (Table 7).

#### Maintenance of international peace and security

33. *Impact of climate change:* On 20 July 2011, the Security Council in its presidential statement, for the first time expressed concern that possible adverse effects of climate change

may, in the long run, aggravate certain existing threats to international peace and security and that the loss of territory of some States caused by sea-level rise, particularly in small low-lying island States, could have possible security implications.<sup>12</sup>

## C. TRENDS

34. *Informal Interactive Discussion*: Informal interactive discussion continues to be an integral part of Council activities, allowing it to exchange views with concerned States on sensitive situations that concern them directly. In 2011, the Council convened five informal interactive discussions, all of which dealt with Africa (Table 8).





#### Agenda management

36. *Utilization of existing agenda items:* In 2011, the Council continued to discuss country/region-specific situations under existing agenda items: Under "Peace and security in Africa", the Council considered the following: Eritrea, briefing by the United Nations Office to African Union (UNOAU), Kenya and Libya; Under "Peace consolidation in West Africa", United Nations Office in West Africa (UNOWA) and piracy and armed robbery at sea in the Gulf of Guinea were discussed. Furthermore, in 2011 the Council took up two new subjects for discussion under the existing thematic agenda item entitled "Maintenance of international peace and security": (i) the interdependence between security and development, and (ii) new challenges to international peace and security and conflict prevention, <sup>13</sup> both of which were introduced on the initiative of the respective Presidency of the month. Lastly, two new sub-agenda items were added under the agenda item "Reports of the Secretary-General on the Sudan": (i) Report of the Secretary-General on the situation in Abyei (UNISFA); and (ii) Report of the Secretary-General on South Sudan (UNMISS) (Table 9).
