
# **UN Security Council in Review**



### January 2022 at a Glance

Under the **Presidency of Norway**, the Security Council held **two high-level signature events**:

• An open debate on **Women and peace and** security, focused on addressing violence targeting women in peace and security processes (18 January). The Minister for Foreign Affairs of Norway presided over the meeting.

• An open debate on **Protection of civilians in armed conflict**, focused on **wars in cities protection of civilians in urban settings** (25 January). The **Prime Minister of Norway** presided over the meeting.

The Council also held two meetings at the ministerial level, a quarterly open debate on the **Middle East, including the Palestinian question** (19 January) with the **Minister for Foreign Affairs of Norway** presiding over the meeting, and a briefing on the **situation in Afghanistan** (26 January), presided over by the **Prime Minister of Norway** with the participation of the Secretary-General.

## **Key Topics**

The **Middle East** was the most frequently considered country- or region-specific item in open and closed discussions (5, 12, 26 and 27 January), followed by **Cyprus** (12, 17 and 27 January) including a private meeting with troopcontributing countries to **UNFICYP**. The **Democratic People's Republic of Korea** (10 and 20 January) and **Libya** (24 and 31 January) were discussed more than once.

Other country or region-specific items considered by the Council included: Afghanistan, Colombia, Mali, the Middle East, including the Palestinian question, Myanmar, Peace consolidation in West Africa and Reports of the Secretary-General on the Sudan and South Sudan. Council members also held their biannual consultations on the **United Nations Regional Centre for Preventive Diplomacy for Central Asia** and discussed **Ethiopia** and the **Sudan** under other matters (AOB).

**Threats to international peace and security** (21 and 31 January) was the most frequently discussed thematic item; informal consultations on the attacks by the Houthis on the **United Arab Emirates** were held in connection with this item and a briefing focused on **Ukraine** was held under this item.

### **Procedural notes**

A digital programme of work was launched by the Presidency of Norway combining all activities of the Security Council.

On 4 January, the annual flag installation ceremony was held to honour the five incoming elected members of the Council, **Albania**, **Brazil**, **Gabon**, **Ghana** and the **United Arab Emirates**, as they began their two-year term on the Council.

On 13 January, the note by the President on the list of Chairs and Vice-Chairs of subsidiary bodies of the Security Council for the period ending 31 December 2022 was issued (see S/2022/2).

On 31 January, at the outset of the meeting held under the item entitled **Threats to international peace and security** focused on Ukraine, the Council's provisional agenda for the meeting was put to a procedural vote and was adopted with ten votes in favour, two against and three abstentions (see S/PV.8960).

### Decisions and press statements

In January 2022, the Council adopted **two resolutions.** The Council did not issue any **presidential statement** during the month.

On 27 January, the Council adopted resolution 2618 (2022), extending the mandate of **UNFICYP** until 31 July 2022. The Council adopted resolution 2619 (2022), on 31 January, extending the mandate of **UNSMIL** until 30 April 2022.

The Council issued **four press statements** on the following topics: the situation in **Yemen** (SC/14765), terrorist attacks in the **United Arab Emirates** (SC/14771) and in **Iraq** (SC/14774) and the peace process in **Colombia** (SC/14781).

## Other activities

On 13 January, in its capacity as the President of the Council for the month, Norway organized a President's retreat on **Preventive Diplomacy and Mediation** (see S/2022/21) which was held in person at the Greentree Foundation in Manhasset, New York.

On 20 January, members of the Council participated in a Virtual Reality experience on **Colombia** in the Security Council Chamber before a briefing on the **UN Verification Mission in Colombia**.
