October 2023 at a Glance







Under the **Presidency of Brazil**, the Security Council held **two signature events**:

- A high-level open debate on Maintenance of international peace and security (20 October), focused on peace through dialogue and the contribution of regional, subregional and bilateral arrangements to the prevention and peaceful resolution of disputes (\$/2023/732).
- A high-level open debate on **Women** and **Peace and Security** (25-26 October) focused on women's participation in international peace and security (S/2023/733). The Minister for Foreign Affairs of Brazil presided over the meeting.

Key Topics

The Middle East, including the Palestinian question (8, 13, 16, 18, 24, 25 and 30 October) was the most frequently considered country- or region-specific item in open and closed discussions. The Middle East (12, 17 and 30 October), Libya (16, 19 and 30 October), Ukraine (9, 13, 27 and 31 October), Haiti (2, 19 and 23 October), Somalia (17, 19 and 31 October), Western Sahara (11, 16 and 30 October), Central African Republic (19 and 26 October) and Colombia (11 and 30 October) were also considered more than once. Other country or region-specific items considered by the Council included: the Democratic Republic of the Congo, Great Lakes Region, Iraq, Kosovo and Sudan and **South Sudan**. Under other matters (AOB), Council members discussed Cyprus and Mali.

In addition to the above, the Council held thematic meetings on Cooperation with regional and subregional organizations, a briefing by the President of the ICJ, and a briefing by the High Commissioner for Refugees.

Procedural notes

In October, further to the request from the President of the Security Council, the Chair of the Peacebuilding Commission provided written advice for the meetings on **Colombia** (S/2023/745) and the **Great Lakes Region** (S/2023/752) under rule 39 of the provisional rules of procedure.

From 5-6 October, the Council traveled to Addis Ababa, Ethiopia, for the 17th Joint Annual Consultative Meeting with the African Union Peace and Security Council (\$/2023/710). Brazil and Mozambique co-led the mission.

On 16, 18 and 25 October (see S/PV.9439, S/PV.9442 and S/PV.9453 respectively), **four draft resolutions** submitted under the item entitled "**The situation in the Middle East, including the Palestinian question**" **failed to be adopted**: two due to the failure to obtain the required number of votes (S/2023/772 and S/2023/795); and two due to the vetoes cast by the United States (S/2023/773) and by both China and the Russian Federation (S/2023/792), respectively. Pursuant to General Assembly resolution 76/262, the Council submitted the corresponding special reports to the General Assembly (A/78/549 and A/78/556).

Decisions and press statements

In October, the Council adopted seven resolutions and issued one presidential statement.

The Council adopted **unanimously** the following **five resolutions**: resolution 2700 (2023), under Chapter VII, renewing the **sanctions regime** concerning **Haiti**, resolution 2701 (2023), renewing the sanctions regime on illicit exports of petroleum from **Libya** and extending for 16 months the mandate of the **Panel of Experts**; resolutions 2702 (2023) and 2704 (2023), extending for one year the mandates of **UNSMIL** and the **United Nations Verification Mission in Colombia**, respectively; and resolution 2705 (2023), extending for one year the mandate of **UNSOM**.

The Council adopted **non-unanimously** the following **two resolutions**: resolution 2699 (2023) adopted under Chapter VII, and with two abstentions by China and the Russian Federation (see S/PV.9430) authorizing the deployment of a **Multinational Security Support** mission in Haiti, led by Kenya, for an initial period of 12 months; and resolution 2703 (2023), adopted with two abstentions by Mozambique and the Russian Federation (see S/PV.9460), renewing for one year the mandate of **MINURSO**.

On 16 October, the Council issued its fifth presidential statement of the year (S/PRST/2023/5), in which it reaffirmed its commitment to the sovereignty, independence, unity, and territorial integrity of the **Democratic Republic of Congo** and expressed its readiness to decide by the end of 2023 on the future of **MONUSCO**.

In October, the Council issued **two press statements** on the following topics: the **terrorist attack in Pule Khomri, Afghanistan** (SC/15442), and the peace process in **Colombia** (SC/15449).

Other activities

In October, Council members convened **two Arria-formula meetings** on the following topics: "**Preventing and Responding to Conflict-Related Sexual Violence**" (18 October), and "**Violations and abuses of human rights and violations of international humanitarian law investigated by the Independent International Commission of Inquiry on Ukraine" (27 October), both organized by Albania, United Kingdom and United States.**
