IRENA hosted and organised a side event during the Ministerial Thematic Forum on Finance and Investment of the UN High Level Dialogue on 25 June 2021. The event took place in the form of a panel discussion, where panelists included the founding partners of the Climate Investment Platform (CIP) as well as GET.Invest, a new partner to the CIP.

The CIP was launched as a joint initiative by IRENA, UNDP and SEforALL, in close cooperation with the Green Climate Fund (GCF) at the Climate Action Summit in September 2019 for the purpose of mobilising capital towards developing countries to accelerate the scale-up of renewable energy technologies deployment with the view to meet Nationally Determined Contributions (NDCs) targets and achieve the Sustainable Development Goals (SDGs). The CIP aims to support countries and projects in bridging existing gaps when it comes to RE project financing, as well as synergise with other initiatives in order to avoid overlap and help accelerate RE deployment across the globe.

The discussion centered around the panelists' individual and collective efforts in respect to working towards the global energy transition through project facilitation, while also addressing the challenges associated with it. The panelists also uncovered the inner workings of the CIP and engaged in a dialogue regarding current and potential impacts of the platform, while also acknowledging aspects that may need improvement.
