# CALL TO ACTION TO CHAMPION YOUTH MAINSTREAMING IN ENERGY COMPACTS

to accelerate a just, inclusive and sustainable energy transition



The involvement and leadership of youth plays a pivotal role in the achievement of a just and inclusive sustainable energy transition—intrinsic to the goals of SDG 7. However, young people continue to face barriers in accessing quality education and training, inclusive financial mechanisms, and meaningful employment opportunities in the sector, that prevent them from leading, participating in, and benefitting from the sustainable energy transition. Oftentimes, young people are overlooked and excluded from decision–making processes in the field of energy, despite their active involvement in their communities and their ambition to take action towards the advancement of the 2030 Agenda.

The Call to Action to Champion Youth Mainstreaming — convened by UNIDO and the SDG 7 Youth Constituency, in partnership with Student Energy and BRICS YEA — calls on governments, the private sector, financial institutions, academia, civil society, and intergovernmental organizations to include youth dimensions in their Energy Compacts that support the advancement of their commitments.

The following recommendations are a follow-up of the <u>Call to Action</u> launched during the Vienna Energy Forum (VEF) Virtual Series in January 2021. The Call to Action urged stakeholders to take immediate action to develop a conducive environment that synergizes and complements avenues of youth engagement, and empower youth to contribute to the sustainable energy transition, as leaders and innovators.

Collectively and individually, the champions of this Call to Action aim to leverage inclusive youth leadership to accelerate action towards a just, inclusive and sustainable energy transition and progress towards SDG 7. The following is a (non-comprehensive) list of recommendations, co-designed by champions of this Call to Action, that highlight pathways to involve and empower youth, as well as mechanisms to mainstream youth dimensions into Energy Compacts. We invite and encourage stakeholders to consider the outlined recommendations when formulating or refining their Energy Compacts.

### RECOMMENDATIONS

1

Assess and strengthen national and regional ecosystems to promote and support youth empowerment and leadership, including meaningful youth participation in policy- and decision-making

- Ensure that the needs, priorities and expertise of youth are incorporated at all stages in the design of relevant policies, spaces, processes and educational programs through accountability mechanisms.
- Enhance knowledge and raise awareness of policy makers to (re)formulate youth-responsive energy policies, including those supporting youth-led initiatives.
- **Build partnerships** with youth, youth-led initiatives and associations; collaborate with them through formal and non-formal mechanisms.
- Establish formal and non-formal engagement mechanisms or platforms for youth inputs [1]. These include providing avenues and support for activities to collect, compile, or present the expertise of youth.

Provide equitable access to productive resources, such as finance, technical knowledge, entrepreneurial training, technical skills development and business development services for youth-led enterprises.

- Enhance financial support and market access for youth-led or youth-owned initiatives, campaigns and/or start-ups, by establishing equitable funding mechanisms or investing in platforms that offer an inclusive range of support to young people, such as accelerators and incubators.
- Endorse or establish initiatives and partnerships that support youth entrepreneurship and leadership on SDG 7, and provide special considerations for engagements with youth from underrepresented and marginalized communities, and youth from the Global South.
- Develop opportunities for youth to enhance technical knowledge and entrepreneurial skills, including networking and mentoring and learning opportunities.

Elevate youth participation in the sustainable energy workforce through the provision of career advancement avenues and the increase of entry-level jobs and training—designed with a youth-centric approach.

- Provide access to accessible, formal and non-formal training and learning opportunities for youth, including mentoring, networking, hands-on and peerto-peer learning spaces, and entry level positions.
- Implement youth-oriented workplace guidelines and policies, including youth professional development mechanisms, university credit opportunities and relevant orientation for supervisors.
- **Establish partnerships** between schools, vocational training institutions, networks, academia and the private sector to ensure that academic skills are aligned with labour market needs.



#### Generate knowledge, monitor and evaluate implemented measures

- Collect age-disaggregated data, conduct analysis on the state of youth involvement in the energy sector and the energy transition, and design datainformed policies and programs.
- Seek youth involvement and inputs in preparation of reports and publications.
- **Develop and disseminate knowledge products**, such as reports, webinars, case studies and articles that highlight youth leadership.



#### Champion diversity, gender equality, women's empowerment and inclusion

- Conduct gender analysis and integrate gender dimensions for the development, implementation and monitoring of all youth-related initiatives and programmes, ensuring that young women have equal opportunities.
- Dedicate resources towards implementing tools that address equity, equality and accessibility, and ensure the inclusive participation of underrepresented and less-privileged youth.
  - Offer free-of-cost learning opportunities and other measures that ensure equitable participation, such as offering Internet stipends for youth in remote communities.
  - Take into consideration linguistic inclusion for accessibility purposes.
- Source expertise and build capacity on gender equality, women's empowerment
  and inclusion of other marginalized groups in the design and implementation of
  policies, programs and other initiatives
- Ensure youth representation from a diverse demography, while providing special considerations for marginalized groups [2] and youth in the Global South.
- Build diverse, impactful and sustainable partnerships at all levels, with NGOs, civil society, financial sector, public and private sector, as well as academia, to ensure effective inclusion and diversity.
