Background

Title: Access to Voucher for Reduction of Energy Consumption in Africa

Access to water and energy is our fundamental human rights. In Africa including Cameroon more than 70% of the people do not have access to energy electricity with companies and businesses making use of water and energy for the production of goods and services with no or limited taxes impose on the usage of water and energy.
